**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On August 7, 2025, the agency received a report regarding a 1-year-old infant with a serious injury. The infant subsequently passed away on August 14, 2025. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office determined the cause of death was due to controlled substance toxicity. As a result of law enforcement's investigation, the infant's father was criminally charged with Neglecting a Child, Consequence is Death. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect of the infant by the father. The infant's half-sibling remained in-home with a Safety Plan. The family's case remained open for ongoing case management services.

At the time of the incident, the infant resided with his mother and his 14-year-old half-sibling. The infant's father had regular visitation.

At the time of the incident, the infant and the infant's 14-year-old sibling were under in-home Child in Need of Protection or Services orders related to the May 11, 2025, CPS Report. The last contact by the agency was at the family home with the mother, the infant, and the infant's 14-year-old half-sibling on July 25, 2025.

On May 11, 2024, the agency screened-in a CPS Report alleging neglect of the infant by the mother. During the assessment period, an additional report was made to the agency regarding the infant sustaining a serious injury. The infant subsequently passed away on August 14, 2025. An assessment of the initial allegation was completed by the agency, and the allegation was unsubstantiated.

On April 12, 2024, the agency screened-in a Services Report. The family was opened for voluntary services.

On May 1, 2017, the agency screened-in a CPS Report alleging neglect to the infant's now 14-year-old half-sibling by the mother. An assessment was completed by the agency with the determination of unable to locate, and the case was closed.

The agency collaborated with law enforcement and medical professionals to complete the assessment.
