**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On September 10, 2025, the agency received a report regarding a 3-year-old child brought to the hospital with a serious injury. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injury was non-accidental in nature. As a result of law enforcement's investigation, the child's mother was criminally charged with Leave/Store Loaded Firearm Near Child. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate neglect of the child by the mother and step-father. The child and his siblings were deemed unsafe, taken into Temporary Physical Custody, and placed with relatives. Petitions for Protection or Services were filed, and the case remained open to provide ongoing case management services.

At the time of the incident, the agency was assessing the August 20, 2025 CPS Report. The last contact by the agency was a home visit with the child, his mother, his step-father, and his siblings on August 27, 2025.

On August 20, 2025, the agency screened-in a CPS Report for Alternative Response alleging neglect to the child and the child's now 5-year-old sibling by the mother and step-father. During the assessment period, an additional report was made to the agency regarding the child being taken to the hospital with a serious injury. An assessment of the initial allegation was completed by the agency with the determination of services needed.

On July 6, 2025, the agency screened-in a CPS Report alleging physical abuse to the child by the step-father and neglect to the child and the child's now 5-year-old and 9-month-old siblings. An assessment was completed by the agency, and the allegations of physical abuse and neglect were unsubstantiated. The case was closed upon completion of the Initial Assessment.

On June 5, 2024, the agency screened-in a Services Report. The agency completed a courtesy home visit for another state.

On August 10, 2023, another agency screened-in a CPS report alleging neglect to the child's now 5-year-old sibling by the mother. An assessment was completed by the agency, and the allegation of neglect was unsubstantiated. The case was closed upon completion of the Initial Assessment.

On June 29, 2023, the agency screened-in a CPS Report alleging physical abuse to the child by an unknown maltreater. An assessment was completed by the agency, and the allegation of physical abuse was unsubstantiated. The case was closed upon completion of the Initial Assessment.

On June 26, 2023, the agency screened-in a CPS Report alleging physical abuse to the child by an unknown maltreater. An assessment was completed by the agency, and the allegation of physical abuse was unsubstantiated. The case was closed upon completion of the Initial Assessment.

The agency collaborated with law enforcement and medical personnel to complete the assessment.
