**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On September 16, 2025, the agency received a report regarding a 9-year-old child who was involved in an egregious incident. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the child had ingested controlled substances. As a result of law enforcement's investigation, the child's father and his significant other were criminally charged with Neglecting a Child. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect of the child by the father and the father's significant other. The child and the child's half-siblings were deemed unsafe, taken into Temporary Physical Custody, and placed with relatives. Petitions for Protection or Services were filed, and the case remained open to provide ongoing case management services.
