**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On September 17, 2025, the agency received a report regarding a 1-week-old infant pronounced deceased in his home. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office noted no signs of trauma to the infant; the autopsy report is pending. No criminal charges have been filed in this case, and the investigation remains open.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the infant by the mother or the mother's significant other and insufficient evidence to substantiate physical abuse of the infant by the mother's significant other. The infant's sibling and minor relative living in the home were deemed safe, and they remained in the home. The family was referred to community services, and the agency closed the case upon completion of the Initial Assessment.

At the time of the incident, the infant resided with his mother, his grandmother, his 6-year-old sibling, and his 13-year-old relative. Paternity had not been established for the infant.

At the time of the incident, the agency was assessing the September 10, 2025 CPS Report. The last contact by the agency was a face-to-face visit with the mother and the infant on September 10, 2025.

On September 10, 2025, the agency screened-in a CPS Report alleging neglect to the infant by the infant's mother. The infant died during the assessment period, and an additional report was made to the agency regarding the infant's death on September 17, 2025. An assessment of the initial allegation was completed by the agency, and the allegation of neglect was unsubstantiated.
