**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On October 18, 2025, the agency received a report regarding a 4-year-old child pronounced deceased due to serious injuries sustained on October 17, 2025. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office determined the child died as a result of serious injuries. As a result of law enforcement's investigation, the child's father was charged with Physical Abuse of a Child (Repeated Acts Causing Death), First Degree Reckless Homicide, Chronic Neglect of a Child (Consequence is Death), and Chronic Neglect of a Child (Specific Harm Did Not Occur). The child's mother was charged with Chronic Neglect of a Child (Consequence is Death) and Chronic Neglect of a Child (Specific Harm Did Not Occur). A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the child by the child's father and neglect of the child by the child's mother. The child's siblings were deemed unsafe, taken into Temporary Physical Custody, and placed with relatives. Petitions for Protection or Services were filed, and the case remained open to provide ongoing case management services.
