Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On December 5, 2025, the agency received a report regarding a 12-year-old child pronounced deceased. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office determined the child's death was non-accidental in nature. As a result of law enforcement's investigation, the child's mother was criminally charged with Neglecting a Child (Consequence is Death). A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect of the child by the child's mother. The agency closed the case upon completion of the Initial Assessment.

At the time of the incident, the child was under an in-home Child in Need of Protection or Services Order related to the May 13, 2024 CPS Report. The last contact by the agency was a phone call with the mother on December 4, 2025.

On May 13, 2024, the agency screened-in a CPS Report alleging neglect to the child by the mother and the mother's significant other. An assessment was completed by the agency, and the allegation of neglect by the mother and the mother's significant other was substantiated. A Petition for Protection or Services was filed on May 17, 2024, and the case remained open to provide ongoing case management services.

On August 16, 2023, another agency screened-in a Services Report. The family was referred to community-based services.

On May 16, 2023, the agency screened-in a CPS Report alleging neglect of the child by the mother and the mother's significant other. An assessment was completed by the agency, and the allegation of neglect by the mother's significant other was substantiated. The allegation of neglect to the child by the child's mother was unsubstantiated. The case was closed upon completion of the Initial Assessment.

On March 7, 2023, another agency screened-in a Services Report. The family was referred to community-based services.

On November 22, 2022, another agency screened-in a Services Report. The family was not in need of any service referrals.

On February 6, 2020, another agency screened-in a CPS Report alleging physical abuse to the child by an unknown maltreater. An assessment was completed by the agency, and the allegation of physical abuse was unsubstantiated. The case was closed upon completion of the Initial Assessment.
