On December 7, 2025, the agency received a report of an egregious incident relating to a 17-year-old child, a 10-year-old child, an 8-year-old child, a 3-year-old child, and a 1-week-old infant that involved the death of the mother of all five children and the father of the 3-year-old child and the 1-week-old infant. Law enforcement was contacted and initiated a criminal investigation. No criminal charges were filed in this case, and the investigation is closed.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement to complete the assessment. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the children by the father of the 3-year-old child and the 1-week-old infant. The agency coordinated emergency guardianship of the children with relatives. The family was referred to community services, and the agency closed the case upon completion of the Initial Assessment.
