Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On December 9, 2025, another agency received a report regarding an 8-month-old infant brought to the hospital with head injuries. Subsequently, the infant was pronounced deceased. The Medical Examiner's Office noted the death was consistent with head trauma; the autopsy report is pending. No criminal charges have been filed in this case, and the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found insufficient evidence to substantiate physical abuse of the infant by an unknown maltreater. The agency closed the case upon completion of the Initial Assessment, and no service referrals were made.

At the time of the incident, the infant was residing in an unlicensed relative home. The infant was originally placed in out-of-home care on October 10, 2025, after she was taken into Temporary Physical Custody due to allegations of neglect by

the mother.

At the time of the incident, the infant resided with her aunt, her uncle, and the aunt and uncle's 4-year-old, 3-year-old, and 1-year old children.
