**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On December 31, 2025, the agency received a report regarding a 5-month-old infant pronounced deceased in his home. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office noted no signs of trauma to the infant; the autopsy report is pending. No criminal charges have been filed in this case, and the investigation remains open.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate neglect of the infant by the mother. The agency deemed the infant's sibling unsafe and initiated a Protective Plan. Subsequently, the mother was assessed as protective, and the infant's sibling remained with the mother. The family's case remained open for voluntary case management services.
