Dear Acting Senate Chief Clerk Hale and Assembly Chief Clerk Blazel:

In compliance with 2009 Wisconsin Act 78, the Child Welfare Public Disclosure Act, please accept the Department of Children and Families' (DCF's) 2024 first quarter report on alleged sexual abuse of children residing in out-of-home care. The data presented below addresses reports of alleged sexual abuse for the period January 1 through March 31, 2024, and fulfills the DCF's reporting requirements under Section 48.981(9)(a), Wis. Stats.

We appreciate the Legislature's interest in Wisconsin's child welfare system and their commitment to supporting DCF, county and tribal child welfare agencies, and the hundreds of non-profit organizations who work to protect Wisconsin children every day. Like you, we are saddened by all cases of child maltreatment and are committed to strengthening families. Wisconsin is fortunate to have dedicated and passionate child welfare workers, and we want to recognize and express our appreciation for their commitment and compassion as they engage in these very challenging situations with children and families on a daily basis.

We encourage legislators and stakeholders to reinforce awareness that prevention of child maltreatment is a community-wide responsibility involving all individuals and organizations in the community, and to continue to support efforts at the local and state levels to develop a more robust and consistent array of child maltreatment prevention services. Through collaborative and data-driven analyses and discussions, we all can support efforts to strengthen the families in our state to provide safe, stable, and nurturing homes for their children and help our families and children succeed and thrive.

The following is a summary of the findings in the <u>report</u>:

Number of Reported Incidents: 37

Wisconsin child protective services agencies screened in and investigated 37 reported incidents of suspected sexual abuse to 30 children residing in out-of-home care.

Dates of the Incidents:

The 37 reported incidents are estimated to have occurred between August 2022 and March 2024. Because children disclose abuse in different stages, it is common for children to report incidents months or even years after the incident occurred. Furthermore, in cases of alleged

abuse involving non-verbal children, dates of alleged maltreatment are often difficult or impossible to determine.

Maltreatment Determinations:

Of the 37 reported incidents, maltreatment determinations were made for 13 (35%) of the reported incidents, while 24 (65%) maltreatment determinations are pending because the investigations are not complete.

Of the 13 reported incidents where the maltreatment determination was made, 10 (77%) were unsubstantiated (i.e., preponderance of the evidence indicating that sexual abuse occurred was not found), two (15%) were substantiated, and one (8%) was unable to be located.

Nature of Maltreater Relationship:

Of the two substantiated incidents, the relationship of the maltreater to the child was a minor not in the placement setting in one incident and a relative primary care provider in one incident.

One of the substantiated incidents included allegations of sex trafficking.

Types of Placement:

Of the two substantiated incidents, one incident occurred while the child was placed in shelter care and one incident occurred while the child was placed in court ordered kinship care.

Location of Substantiated Incidents:

Of the two substantiated incidents of sexual abuse to children residing in out-of-home care, one incident occurred in Milwaukee County and one incident occurred in Racine County.

Ages or Age Group of Children:

The alleged sexual abuse was reported and investigated for children 3-17 years of age. Incidents of sexual abuse were substantiated for two children, one of whom was 16 years old and one of whom was 17 years old.
