Dear Senate Chief Cyrus Anderson and Assembly Chief Clerk Blazel:

In compliance with 2009 Wisconsin Act 78, the Child Welfare Public Disclosure Act, please accept the Department of Children and Families' (DCF's) 2025 first quarter report on alleged sexual abuse of children residing in out-of-home care. The data presented below addresses reports of alleged sexual abuse for the period January 1 to March 31, 2025, and fulfills the DCF's reporting requirements under Section 48.981(9)(a), Wis. Stats.

We appreciate the Legislature's interest in Wisconsin's child welfare system and their commitment to supporting DCF, county and tribal child welfare agencies, and the hundreds of non-profit organizations who work to protect Wisconsin children every day. Like you, we are saddened by all cases of child maltreatment and are committed to strengthening families. Wisconsin is fortunate to have dedicated and passionate child welfare professionals, and we want to recognize and express our appreciation for their commitment and compassion as they engage in these very challenging situations with children and families on a daily basis.

We encourage legislators and stakeholders to reinforce awareness that prevention of child maltreatment is a community-wide responsibility involving all individuals and organizations in the community, and to continue to support efforts at the local and state levels to develop a more robust and consistent array of child maltreatment prevention services. Through collaborative and data-driven analyses and discussions, we all can support efforts to strengthen the families in our state to provide safe, stable, and nurturing homes for their children and help our families and children succeed and thrive.

The following is a summary of the findings in the <u>report</u>:

Number of Reported Incidents: 36

Wisconsin child protective services agencies screened in and investigated 36 reported incidents of suspected sexual abuse to 30 children residing in out-of-home care.

Dates of the Incidents:

The 36 reported incidents are estimated to have occurred between October 2022 and March 2025. Because children disclose abuse in different stages, it is common for children to report incidents months or even years after the incident occurred. Furthermore, in cases of alleged

abuse involving non-verbal children, dates of alleged maltreatment are often difficult or impossible to determine.

Maltreatment Determinations:

Of the 36 reported incidents, maltreatment determinations were made for 19 (53%) of the reported incidents, while 17 (47%) maltreatment determinations are pending because the investigations are not complete.

Of the 19 reported incidents where the maltreatment determination was made, 11(58%) were unsubstantiated (i.e., preponderance of the evidence indicating that sexual abuse occurred was not found), six (32%) were substantiated, and two (10%) were not able to locate source.

Nature of Maltreater Relationship:

Of the six substantiated incidents, the relationship of the maltreater to the child was a minor maltreater in the placement setting in three incidents, a minor maltreater not in the placement setting in one incident, a temporary caregiver in one incident, and a relative court-ordered care provider in one incident. None of the six substantiated incidents included allegations of sex trafficking.

Types of Placement Settings:

Of the six substantiated incidents, one incident occurred while the child was placed in a relative unlicensed home, one incident occurred while the child was placed in a non-relative treatment foster home, one incident occurred while the child was placed in a non-relative foster home, one incident occurred while the child was placed in a court-ordered kinship care placement, one incident occurred while the child was placed in a non-relative unlicensed home, and one incident occurred while the child was placed in a group home.

Location of Substantiated Incidents:

Of the six substantiated incidents of sexual abuse to children residing in out-of-home care, two incidents occurred in Grant County, one incident occurred in Dane County, one incident occurred in Green County, one incident occurred in Marathon County, and one incident occurred in Wood County.

Ages or Age Group of Children:

The alleged sexual abuse was reported and investigated for children 1-17 years of age. Incidents of sexual abuse were substantiated for six children. The six substantiated incidents of sexual abuse involved six children, ages 4, 6, 9, 11, 14, 16.
