

ORAL CASE PRESENTATION TOOL

Initial PRT- ICWA CASE

Instructions to the Ongoing Case Manager and Supervisor: Use the outline below to prepare your **20-minute** oral case presentation. Both the Tribal Worker and Ongoing Case Manager can present equally or in conjunction with each other. Please consult with the tribal worker to plan your time effectively, all voices are important, acknowledged, and appreciated.

1. Briefly describe the child (age, gender), the child's family (including any siblings in or out of custody), and the child's current living situation.
2. Describe child's tribal affiliation and membership status. If the child is eligible, what steps has the county taken to assist the family with enrolling the child? Describe any barriers.
3. Describe other significant relationships with caring adults in the child's life; include any significant relationships with community members, extended family, clan members, and kinship system.
4. When was the child originally removed from his/her home? Has the child been in more than one out of home placement, briefly describe the reasons and placement types.
 - Does the child's current placement meet the placement preferences defined by the tribe?
 - Does the tribe support the current placement? If no, describe efforts made to meet the placement preferences of the tribe.
5. What were the original threats that prompted the removal of the child(ren)?
 - Describe the county's active efforts to provide services and programs to prevent the breakup of the Indian Family.
6. Have any new threats emerged since placement?
7. What is the current status of the impending danger(s)?
8. Do the child and parent/caregiver have any interactions, if so, how often, how consistent, what is the length of the interactions (day, overnight, weekend, etc.)?
9. What arrangements were made to provide natural and unsupervised family interaction in the most natural setting that can ensure the Indian child's safety, as appropriate to the goals of the Indian child's permanency plan, including arrangements for transportation and other assistance to enable family members to participate in that interaction? 48.028(g)(1)(g)
10. Describe how the Tribe was engaged in family assessment and visitation planning.
11. Have there been any positive changes in the parent/caregiver behavior, attitudes, motivation, and interactions to produce a safe home? Is the parent demonstrative of protective behaviors, making use of community resources, etc.?
12. Describe the child's issues, challenges, needs (physical, social, emotional, behavioral and developmental) that may be affecting progress toward permanency.
13. When was the CANS completed for the child, what is the child's Level of Need and the actionable items that were identified?
14. What cultural activities does the child participate in?
15. Describe the child's current educational needs.
16. Describe the parent(s)' issues, challenges, needs that may be affecting progress toward permanency.
 - Describe the active efforts to provide rehabilitative services to reunify the family.
17. Would the parents/caregivers be willing and capable of supporting reunification and an in home safety plan?
18. What permanency options does the Tribe support? Adoption, Reunification, Guardianship/ Subsidized Guardianship
19. Describe the services and supports being provided for this child and family, indicating what is/is not working and in your opinion why.
20. Describe any court processes that may be affecting progress toward permanency in this case.
21. Describe other issues, challenges, needs that may be affecting progress toward permanency.
22. Clarify and Explore Questions
 - State the current and concurrent permanency goal of record for this child; if it is not reunification, please explain.
 - When is the last time you had a full disclosure conversation with one of the parents?
 - When is the last time you spoke to the child/youth regarding where they wanted to live?
