As provided in the biennial budget (2009 Wisconsin Act 28) and the promulgation of the Permanent Rules for Foster Care and Adoption, the second phase of the Levels of Care Foster Care Licensing Initiative became effective September 1, 2011. A summary of the changes from the proposed permanent rule from the public hearings are attached at the end of this document. As a result of the permanent rule, the Division has created a number of tools to assist counties, tribes, and Child Placing Agencies with the changes to the foster care and adoption programs.

## Documenting a Foster Care Maintenance Rate for Receiving/Assessment Homes, First 30 Days

The interim method to appropriately document use of receiving/assessment homes is provided in the updated "How Do I Guide": <u>https://dcf.wisconsin.gov/knowledgeweb/training/ewisacwis-user-guides</u>

To document a rate setting for the Basic and Exceptional components of the Uniform Foster Care Rate during the first 30 days a worker may make a one-time only payment or use the interim method while the child's team is working on completing the CANS for the Supplemental portion of the maintenance rate for placements in receiving/assessment foster homes when the 30 day timeframe spans more than one month.

Placement in a receiving/assessment foster home constitutes a placement into foster care, which typically occurs at the beginning of a placement episode. Children placed in these settings are subject to the Uniform Foster Care Rate (UFCR) setting policy regardless of how payment to these providers is arranged by the agency. For instance some agencies agree to pay a higher amount to foster families during the first 10 days if they are willing to accept placements during on-call hours or with little notice.

The placement must be ended on or before the 30th day of placement to coincide with policy; if the child remains in the same foster home this does not mean that the deadline for completing the CANS has been extended an additional 30 days. If the placement is to continue, a new placement and subsequent UFCR (reflecting actual supplemental and exceptional fees) should be created, as stated in DSP Memo Series 2011-03 Uniform Foster Care Rate Setting.

With the addition of the new service type for a 30 day pre-CANS, the Reporting Category will need to be updated by your agency financial worker. This update will ensure that the financial interface works.

## **Technical Assistance**

The Division is committed to continuing to provide technical assistance regarding the Levels of Care Foster Care Licensing Initiative and the changes to the Foster Care program.
