Re: DCF and DOC CIP Transfer

PURPOSE

The intent of this memo is to notify counties and provide guidance on the transfer of the Community Intervention Program (CIP) from the Department of Corrections to the Department of Children and Families.

BACKGROUND

As directed in Act 55, the 2015-17 biennial budget bill, in January 2016 administration and oversight responsibility for the community-based juvenile justice system transfers from the Department of Correction (DOC) to the Department of Children and Families (DCF). This transfer includes transitioning the Community Intervention Program for SFY 16 (July 1, 2015 through June 30, 2016) to DCF beginning January 1, 2016. The Community Intervention Program statute is renumbered s. 48.528 effective January 1, 2016, and amended by 2015 Wis. Act 55.

Transition

Counties may continue to submit invoices for reimbursement to DOC through December 30, 2015.

Invoices must be received by DOC by December 30. Any invoices received by DOC after December 30 will be forwarded to DCF for entry into the DCF CORE system.

Counties submitting invoices for reimbursement after December 30 will need to submit through the DCF CORE system, using CORE code 3410.

DCF will continue to require submission of plans and evaluations for the CIP. DCF will notify the counties of the available funding in Quarter 2 of 2016, as well as specific dates and requirements for evaluations and plans, through DCF Administrator's Memos.
