FY 2016 Reimbursement for High-Cost Indian Juvenile Placements: Eligibility and Re:

Application for Funding

PURPOSE

This memo provides information about FY 2016 Reimbursement for High-Cost Indian Juvenile Placements for unexpected or unusually high-cost out-of-home care placements of Indian Juveniles who have been adjudicated delinquent by tribal courts.

BACKGROUND

State statute WI s. 938.485(4) allows the Department of Children and Families (DCF) to reimburse Indian tribes and county departments "for unexpected or unusually high-cost out-of-home care placements of Indian Juveniles who have been adjudicated delinquent by tribal courts." The phrase "unusually high-cost out-of-home placements" means "the amount by which the cost to an Indian tribe or to a county department of out-of-home care placements of Indian juveniles who have been adjudicated delinquent by tribal courts exceeds \$50,000 in a fiscal year." A total of \$75,000 is provided through 2009 Wisconsin Act 28 to reimburse tribes and counties each state fiscal year through this program.

On January 1, 2016, DCF assumed responsibility for the community-based juvenile justice system. This change included the transfer of responsibility for this program under s. 938.485(4) to DCF.

INFORMATION SUMMARY

1. Eligibility for FY 2016 Reimbursement

As required by statute, high-cost out-of-home care placements must meet the following criteria:

- The Indian tribe or county department incurs out-of-home care placement costs.
- Eligible youth are Indian juveniles who have been adjudicated delinquent by a tribal court.
- The FY 2016 (July 1, 2015 through June 30, 2016) cost exceeds \$50,000.

To be eligible for reimbursement, a tribe or county must provide the following information:

- Complete Attachment 1, which summarizes out-of-home placement costs eligible for reimbursement. This application form also requests contact information in case there are questions about the information on the application.
- A copy of the tribal court delinquency order for each youth included in the request for reimbursement.

Requests for costs incurred outside the eligibility period (July 1, 2015 through June 30, 2016) will result in a corresponding reduction in the reimbursement request amount. A county department may not claim costs for eligible youth incurred by the county but reimbursed by a tribe. However, a tribe may claim costs for reimbursing a county for out-of-home placements for eligible youth.

2. Department Review and Awards Process

A total of \$75,000 is provided through 2009 Wisconsin Act 28 to reimburse tribes and counties each state fiscal year through this program. Only out-of-home placement costs exceeding \$50,000 for a tribe or county are eligible for reimbursement. If requests exceed the available budgeted amount, the reimbursement will be allocated according to each tribe's or county's share of the total cost eligible for reimbursement.

Eligible tribes or counties must complete the attached Application for Reimbursement and return it by email to the Juvenile Justice Policy Coordinator, at DCFJJ@wisconsin.gov by 5:00 pm on Wednesday, December 21, 2016.
