## **PURPOSE**

The purpose of this memo is to provide a summary of existing statutory provisions relating to county authority to contract with other entities to perform certain child protective services (CPS) functions. Please note that this document should not be construed as legal guidance. Counties with questions about compliance with these provisions should seek legal advice from their local legal representative. This document replaces the Contracting Provisions for Non-Milwaukee Counties for Child Welfare Functions Under Wis. Stat. § 48.981 issued on April 14, 2020.

## **POLICY AND PROCEDURE REQUIREMENTS**

In Wisconsin, pursuant to Chapter 48 child welfare functions are performed by county departments or, in Milwaukee County, the Department of Children and Families (DCF) Division of Milwaukee Child Protective Services (DMCPS). Under Wis. Stat. § 48.981, non-Milwaukee counties have the statutory authority to contract with certain entities for certain child welfare functions as follows:

- Contracts with Licensed Child Welfare Agencies (s.48.981(3)(cm)):
  - Wis. Stat. § 48.981(3)(cm) provides:
     Contract with licensed child welfare agencies. A county department may contract with a licensed child welfare agency to fulfill the county department's duties specified under par. (c) 1., 2. b., 2m. b., 5., 5r., 6., 6m., and 8. The department may





- contract with a licensed child welfare agency to fulfill the department's duties specified under par. (c) 1., 2. a., 2m. b., 3., 4., 5., 5m., 5r., 6., 6m., 7., 8., and 9. in a county having a population of 750,000 or more. The confidentiality provisions specified in sub. (7) shall apply to any licensed child welfare agency with which a county department or the department contracts.
- o In summary, this provisions permits non-Milwaukee county departments to contract with a licensed child welfare agency for the duties of Access and Screening under s. 48.981(3)(c)1, Completing the portion of the Initial Assessment (IA) described in s. 48.981(3)(c)1, Taking Temporary Physical Custody of a child or expectant mother (together with an employee of the county department) under s. 48.981(3)(c)2.b and 2m.b, Maintaining and updating records of actions under s. 48.981(3)(c)5, Providing Maltreatment Determinations to DCF under s. 48.981(3)(c)5r, Notifying a mandated reporter and relative reporter regarding action taken on a suspected maltreatment report under s. 48.981(3)(c)6 and 6m, and Providing information to DCF on each report and IA under s. 2 | Page 48.981(3)(c)8. Please note that currently no licensed Child Placing Agencies are licensed to perform any of the
- Contracts with other Counties or DCF/DMCPS (s. 48.981(3)(cr)):

functions under s.48.981(3)(cm).

- Wis. Stat. § 48.981(3)(cr) provides:
   Contracts to perform child protective services. With the approval of the department, a county department may contract with one or more county departments or the department in a county having a population of 750,000 or more under s. 66.0301 to fulfill the county department's duties under this subsection and sub. (3m).
- o In summary, this provision permits county departments to contract with one or more other county departments or DCF/DMCPS, but not licensed child welfare agencies, for all of the duties under s. 48.981(3) & (3m), subject to the approval of the Department of Children and Families and consistent with s.66.0301. Duties under s. 48.981(3) & (3m) include: Access and Screening under s. 48.981(3)(c)1, Completing the portion of the Initial Assessment (IA) described in s. 48.981(3)(c)1, Taking Temporary Physical Custody of a child or expectant mother under s. 48.981(3)(c)2, Offering services/filing a CHIPS petition under s. 48.981(3)(c)3, Issuing a maltreatment determination under s. 48.981(3)(c)4, Maintaining and updating records of actions under s. 48.981(3)(c)5, Issuing a maltreater determination to individual and information regarding appeal process under s. 48.981(3)(c)5m, Providing maltreater determination information to DCF





under s. 48.981(3)(c)5r, Notifying a mandated reporter and relative reporter regarding action taken on a suspected maltreatment report under s. 48.981(3)(c)6 and 6m, Developing services to address child abuse and unborn child abuse under s. 48.981(3)(c)7, Providing information to DCF on each report and IA under s. 48.981(3)(c)8, Filing a petition for a child abuse restraining order and injunction under s. 48.981(3)(c)9, and Providing Alternative Response under s. 48.981(3m).

Please note that in contracting with other entities for child welfare functions, as provided above, training requirements in statute and administrative rule must still be met. See e.g., Wis. Stat. § 48.981(8) and DCF 43.
