About the Wisconsin Out-of-Home Care (OHC) Report

The Out-of-Home Care (OHC) Report provides an overview of children placed in OHC throughout the 2023 calendar year. This year's report is reflective of changes compared to the prior report to better represent the current landscape and trajectory experienced by children and youth while they are in Wisconsin's out-of-home care system.

The OHC Report provides information on children in OHC placements during calendar year (CY) 2023 and on December 31, 2023. This report includes information on demographics, trends in the OHC system, placement data, and outcomes data (stability, discharges, length of stay, etc.). Counts presented in this report may differ from other published information depending on data maturity, the scrape of data utilized, or the source.

Wisconsin remains committed to continued improvements in putting families first and reducing racial disproportionality throughout the system. In 2023, the Department of Children and Families (DCF) invested more than \$11 million in in-home support and over 30,000 training hours through Wisconsin's workforce training program. Between 2019 and 2023, Wisconsin removed **4 fewer** children per day and decreased the overall number of children served in OHC by **21**%.

DCF remains committed to using data to better understand racial disparity in our system. Data are used to evaluate programs and policies, implement initiatives to correct inequities, and address disproportionality for children and families of color in the child welfare system. The data confirms DCF's commitment is critical as significant disproportionality persists throughout the OHC system for children and families of color. Though Wisconsin continues to see a decreasing trend in children in OHC, significant racial disparities persist for Black/African American children who are consistently overrepresented by 30% in multiple facets of the child welfare system.

DCF thanks individuals with lived experience, local and tribal child welfare agencies, service providers, and placement providers for ensuring that all children are safe and loved members of thriving families and communities.




Putting Families First

Wisconsin's OHC Landscape


A total of **9,812** children were served in OHC in 2023. As the number of children served in OHC declines each year, there has been a **21%** reduction since 2019. In this same time frame, Wisconsin has seen a **28%** decrease in children entering OHC. If Wisconsin continues this trend, the state should continue to see fewer children in OHC in the future.




Who is entering OHC?

Over the last decade, neglect has continued to be the primary identified reason for removal. While the number of children entering OHC due to neglect is decreasing, it remains the most prevalent reason for children entering OHC, with nearly 54% of children having at least one removal reason identified as neglect. Compared to the prior year, there was a reduction in 11 percentage points of children entering OHC due to neglect and an increase in children entering due to caretaker drug abuse, child behavior, and incarcerated caretaker.

Why are children entering into OHC? Neglect




Trends of the top seven removal reason rates of the past 5 years



Who is in OHC?

Race and ethnicity of children in OHC compared with general population*^



The data on this page are a count of 6,143 children residing in OHC on 12/31/2023.

Although the overall number of children in OHC decreased from 2019 to 2023, the population of children in OHC who are Black/African American increased from 31% to 34%. The Black/African American children's entry and OHC rate is 3x higher than the Black/African American children living in the state. Similarly, the Native American children's entry and OHC rate is 4.5x higher than the Native American children living in the state.

The majority (70%) of children served in OHC were aged 0-11 years old. The proportions of age groups has remained constant over the past five years, even as the number of children in OHC decreased.

3% of children entering OHC are children with a previous adoption. This has remained consistent over the past five years. Over 60% of this group of children entered directly into a congregate care, shelter, or institution placement.


Disparities are prevalent for children who re-enter OHC post-adoption, disproportionately affecting Black/African American and Native American children. In 2023, Black/African American children comprised 30% of OHC entries but comprised 42% of re-entries post-adoption.



Initial Placement Impacts Child's Experience in OHC

In 2023, 62% of children in Wisconsin were not placed with a relative when they first entered OHC. This is an increase of 2 percentage points from the previous year, showing a shift away from placing children with a family member. Children's initial placement matters as exposure to the child welfare system inflicts lasting trauma. If OHC is necessary, children should be placed with a relative, and only when that is not an option should the next least restrictive setting be considered.



Initial Placement Impacts Child's Experience in OHC

When children are placed with relatives, they are less likely to experience subsequent placement moves. In 2023, of all children initially placed with a relative, **74%** did not experience any placement changes during 2023.

Children's stability in OHC impacted by initial placement



In 2023, children *initially* placed with a non-relative foster home changed placements twice as often as children initially placed with a relative. Children initially placed in non-family settings fared worse. While this may seem small, remember every move a child makes in OHC is a change to their structure and routine. DCF is continuing to implement strategies to improve a child's stability in OHC.

Relative Placement is Best for Children

If a child needs to be placed in OHC, placing children with a family member is preferred as it is the best way to maintain family connections.

Compared to the prior year, children in OHC saw a decrease in placement with a family member. As of 12/31/2023, placements in family-like settings made up a majority of OHC placements (88%), including 40% of children placed with relatives and 48% with non-relative foster homes. The median length of stay for children placed with a relative was five months less than children placed in any other type of placement.


Placements of children in OHC






Median length of stay by placement on 12/31 of each calendar year

Placement Stability



The benefits of placing children with a relative are seen throughout a child's experience in OHC. Children in relative settings experienced the fewest placement moves. Of the children in OHC at the end of the year, those in relative foster homes experienced fewer placements throughout their time in OHC. Conversely, children experience more placements in their lifetime when placed in non-family settings.




Supporting Children Leaving OHC

Returning children to their families and known communities is the most desirable outcome for children leaving OHC. In 2023, 90% of children who exited OHC achieved legal permanency. Over the past five years, while children who exited OHC due to adoption and guardianship slightly increased, reunification decreased.

Over 50% of Wisconsin children in OHC return home to their family.



Discharges over time



In 2023, 56% of the youth that aged out were in OHC for over 2 years.


When reunification is not possible, adoption and guardianship are considered other options of legal permanency for the child. In 2023, 17% of children were adopted and 19% discharged to guardianship.

Supporting Children Leaving OHC


More children exited OHC (3,964) than entered (3,666) in 2023. Children have a better chance of thriving when they return to the safety and security of their life with their families.

Length of stay in OHC decreased in 2023 from 2022. Children that exited OHC spent a median of 15.5 months in OHC, while on average children spent 20.6 months in OHC. This means there are some children in OHC much longer than their peers.

Children returning to OHC




As of 12/31/2023, 21% of children in OHC have been in OHC multiple times throughout their childhood. While the federal standard for re-entry rate is 8.3%, Wisconsin's reentry rate was 10.4% for children who re-entered OHC within 12 months of returning home.

Supporting Children Leaving OHC

In 2023, **48%** of children exiting OHC were White, **29%** of children were Black/African American, **10%** of children were Hispanic/Latino, **10%** of children were Native American, and **1%** of children were Asian. The proportion of children exiting OHC by race stayed consistent for the past five years. Although more children have been exiting OHC, Black/African American children were the only group of children who exited OHC at a rate lower than the number of children that were in OHC.

In 2023, while the median time in OHC for all children aged 15 and over exiting was **12 months**, Black/African American children in this age group exiting OHC had a median of **12.6 months**.

Changes in the 2023 OHC Report

2023 Changes

1. Section: Who is Entering OHC?

The Adoption and Foster Care Analysis and Reporting System (AFCARS) from the Children's Bureau enacted a final rule in 2020 with new additions and revisions to the removal reasons, section 1355.44(d). This is the comprehensive list of new additions and/or revisions to the removal reason elements 72-105: runaway, whereabouts unknown, medical neglect, domestic violence, abandonment, caretaker failure to return, prenatal alcohol exposure, prenatal drug exposure, diagnosed condition, inadequate access to mental health services, inadequate access to medical services, death of caretaker, incarceration of caretaker, caretaker significant impairment cognitive, caretaker significant impairment physical emotional, relinquishment, child requested placement, sex trafficking, parental immigration detainment or deportation, family conflict related to child's sexual gender, education neglect, public agency Title IV-E agreement, Tribal title IV-E agreement, and homelessness.

2. Section: Who is in OHC

Added information on adopted disruptions.

3. Section: Initial Placement Impacts Child's Experience in OHC

Prior report included a pie chart on initial placements for one year. This year's report shows a five-year trend on initial placement settings. Children's stability bar chart in the prior report consolidated placement settings to relative, congregate care, and all other non-relative. This year's report expands placement settings to relative, non-relative foster home, congregate care, detention, shelter and other.

4. Section: Relative Placement is Best for Children

Prior report shows placement settings for one date. This year's report shows a five-year trend on placements of children in OHC.

5. Section: Placement Stability

Placement proportions and average placement chart shows a 10-year history of placements per child. Placement categories groupings have been changed to be consistent throughout the report.

6. Section: Supporting Children Leaving OHC

A new bar chart conveying children exiting OHC compared to children in OHC by race and ethnicity has been added to this year's report.

7. Section: Frequently Asked Date Points - Disability

Previous disability options: Emotionally Dysregulated, Learning Disability, Mental Disability, Other Medically Diagnosed Disability, Physical Disability, and Visual/Hearing Impaired. New choices are ADD, ADHD, Anxiety, Asthma, Autism Spectrum Disorder, Congenital Malformation, Depression, Developmental Delay, Developmental Disability, Diabetes, Emotionally Disturbed, Hearing Impairment and Deafness, Intellectual Disability, Learning Disability, Mental/Emotional Disorders, Orthopedic Impairment or Other Physical Condition, Other Diagnosed Conditions(s), Reactive Attachment Disorder, Seizure Disorder, Serious Emotional Disturbances, Serious Mental Disorders, Visual Impairment and Blindness.

8. Section Appendices

Added a new appendix I showing five-year entry trends by county.

9. Additional changes to data

A change to this data point has been made to this year's report: "An overwhelming majority of children who went missing from a congregate care setting were Black/African American girls (67%)." The data point has been updated to 40%. The language for the prior report should have been Of all girls missing in care, 67% were Black/African American girls. Removal of racial disparity in OHC section. Disparity is now weaved throughout the report.



Appendix A

Out-of-Home Care Provider Types

In Wisconsin, there are a variety of placement settings which can be used to best meet the needs of a given child or youth. These settings are addressed in this report and include the following:

Foster Family Homes: Foster family homes can include both the home of a relative (e.g. voluntary, court-ordered or long-term kinship care) and unrelated individuals. Foster family homes are licensed by local child welfare agencies based on state statutes. Receiving homes are licensed foster homes that take children on emergency placements/short term placements.

Treatment Foster Homes: Treatment foster homes are licensed by child placing agencies, either through a county or a private agency. Private child placing agencies are licensed by Department of Children and Families (DCF). Treatment foster homes serve children with more intensive service needs that require specialized care.

Pre-Adoptive Homes: Pre-adoptive foster homes are licensed by a county or public adoptions. Children are placed in pre-adoptive homes with the intention of permanency being met by adoption in the near future. Adoptions occur with both relatives or non-relatives.

Group Homes: A group home is a facility operated by a person licensed by DCF to provide 24 hour care for 5-8 residents. Within this report, this category includes providers with Qualified Residential Treatment Proogram (QRTP) certification.

Residential Care Centers (RCCs): RCCs are residential facilities that are operated by local child welfare agencies licensed pursuant to section 48.60 of Wisconsin Statutes for the care and maintenance of children. Children placed in a RCC have significant needs that cannot be addressed in a family setting. Within this report, this category includes providers with Qualified Residential Treatment Proogram (QRTP) certification.

Shelter Care Facilities (SC): Shelter care facilities provide short-term (not to exceed a total of 60 days), non-secure residential care and physical custody to children pending court action or voluntary placements for under 20 days or crisis stabilization services for up to 5 days.

Detention: A detention facility under certain circumstances can be used as an out-of-home care placement when being used as or becomes a primary physical placement of the child.

Hospital/Mental Health Facility: Hospital/mental health facility could be used as an out-of-home care placement when the child subsequently enters into one of the placement settings listed above or when the hospital or inpatient facility placement takes place within a current placement episode.

Youth/Adult Correctional Facilities: Youth/adult correctional facilities are secured facilities operated by the Department of Corrections.

Appendix J

ICWA and Native American Status

A child's and provider's Native American status is determined based on race, ethnicity, or ICWA status. Below are the eWiSACWIS documentation guidelines for ICWA and Native American status:

ICWA (Indian Child Welfare Act)

In eWiSACWIS, there are up to three Tribal Membership statuses documented for a child/provider. ICWA status for a child/provider is determined based on these statuses, as identified below –

- ICWA Child/Provider status is set to 'Yes', when the Tribal Membership status is any of the following -
 - (a) Member
 - (b) Eligible for membership, not a member
 - (c) Pending
- ICWA Child/Provider status is set to 'No', when any of the Tribal Membership status is 'Not eligible for membership'
- ICWA Child/Provider status is set to 'Unknown', when there is no information documented for a child for Tribal Membership status. In absence of any information, the status cannot be identified and is set to 'Unknown'.

Native American

In eWiSACWIS, there are up to five different races documented for a child. Native American status for a child/provider is determined based on race, ethnicity or ICWA status for a child/provider, as identified below –

Native American child/provider status is set to 'Yes', when any of the following is true -

- Child/Provider race is 'American Indian/Alaska Native' (across all five races) or
- Child/Provider ethnicity is 'Native American' or
- Child/Provider ICWA status is 'Yes'. (Refer to the explanation above on how to determine ICWA child)

Native American child/provider status is set to 'No', when child/provider's race, ethnicity and ICWA status do not match the required information as outlined above.

Appendix K

Key Definitions

Child: Term used to address both children and youth served by county child welfare agencies, county youth justice agencies, DMCPS, and public adoptions.

Discharge: A child's OHC episode ends with the date a child is discharged from OHC. The discharge date represents the date the child achieves a permanent outcome, which is reunification, adoption, or guardianship.

Placement: The use of a facility or home provider for the physical placement of the child who has been removed from their family home.

OHC Episode: A placement episode starts with a child's removal from home and ends with a discharge from OHC to a permanent home or to independent living. A child may be placed in multiple placement settings within a placement episode.

Placement Settings: Child welfare agencies attempt to have a child stay in only one setting during their OHC episode. However, in some cases a child may be placed with multiple providers or in different placement facilities during a single placement episode. These changes may be due to actions initiated by the agency, the provider, the child, the parent, or the court. Placement settings include:

- Foster homes, including receiving homes, foster family homes of all levels and pre-adoptive foster homes
- Unlicensed relative and non-relative homes
- Group homes
- Residential care centers (RCCs)
- Court Ordered Kinship Care
- Shelter care
- Detention
- Trial reunification
- Supervised independent living
- Hospital/Mental Health facility
- Missing from OHC

A child or youth is considered Missing from OHC when they are under the placement and care responsibility of the department or a county agency, living in an OHC setting, and any of the following criteria are met:

- The child or youth has been missing for 8 hours or for a period of time that cannot reasonably be justified by the child or youth's age, maturity, or emotional capacity as well as documenting the child's or youth's missing episode in eWiSACWIS within 24 hours.
- When efforts to locate the child or youth have been unsuccessful.
- When it is known or suspected that a child or youth has been taken by force or coercion.
- When the child or youth is in the company of an unauthorized person or located in an unauthorized place.

Removal: A child's placement episode begins with the date of the child's removal from their home. The child is taken into physical custody and enters into OHC under a court order or via a formal voluntary placement agreement among the agency, the parents, and the placement provider. Information regarding the types of out-of-home care providers used can be found in Appendix B.

Use of Average vs. Median: The OHC report uses both calculations of average and median. While similar, each formula can provide a different perspective. An average provides a number that represents the entire dataset, including outliers. When outliers exist in a dataset, they can bring an average up or down. For example, if a child has been in OHC for many years, that long episode will make the average length of stay for the entire dataset longer. A median provides the value of the middle of the dataset. For example, if a majority of children in OHC are in placement for 13 months, the median would be 13 months, regardless of any outliers of children with particularly long episodes.
