# **Federal Update**

DPI's Policy Initiative Advisor in the Office of the State Superintendent also emphasized the uncertainty and unknowns around federal education spending and the shutdown.

Department of Health (DHS) Office of the Secretary's Policy Director echoed the uncertainty and unknowns pertaining to the impact of potential federal cuts alongside the shutdown.

The Wisconsin Head Start Association (WHSA) Executive Director provided updates on Head Start as it relates to federal funding.

Council members asked questions and provided feedback on the federal budget update.

### **State Budget Review**

The Council heard and discussed agency budget overviews from DCF, DPI, and DHS.

#### **Get Kids Ready**

The Council received a presentation on Get Kids Ready program, a new a new community-based school readiness initiative to support licensed and certified child care providers serving four-year-olds.

#### **WMELS Revision**

The Council heard a presentation on the revision of the Wisconsin Model Early Learning Standards (WMELS) which currently serve as the state's early learning and development guidelines.

#### **Public Comment**

The Council will hear comments and updates from members of the public. Rebecca Murray shared information about an upcoming series of Family Friendliness as a Workforce Strategy seminars.
