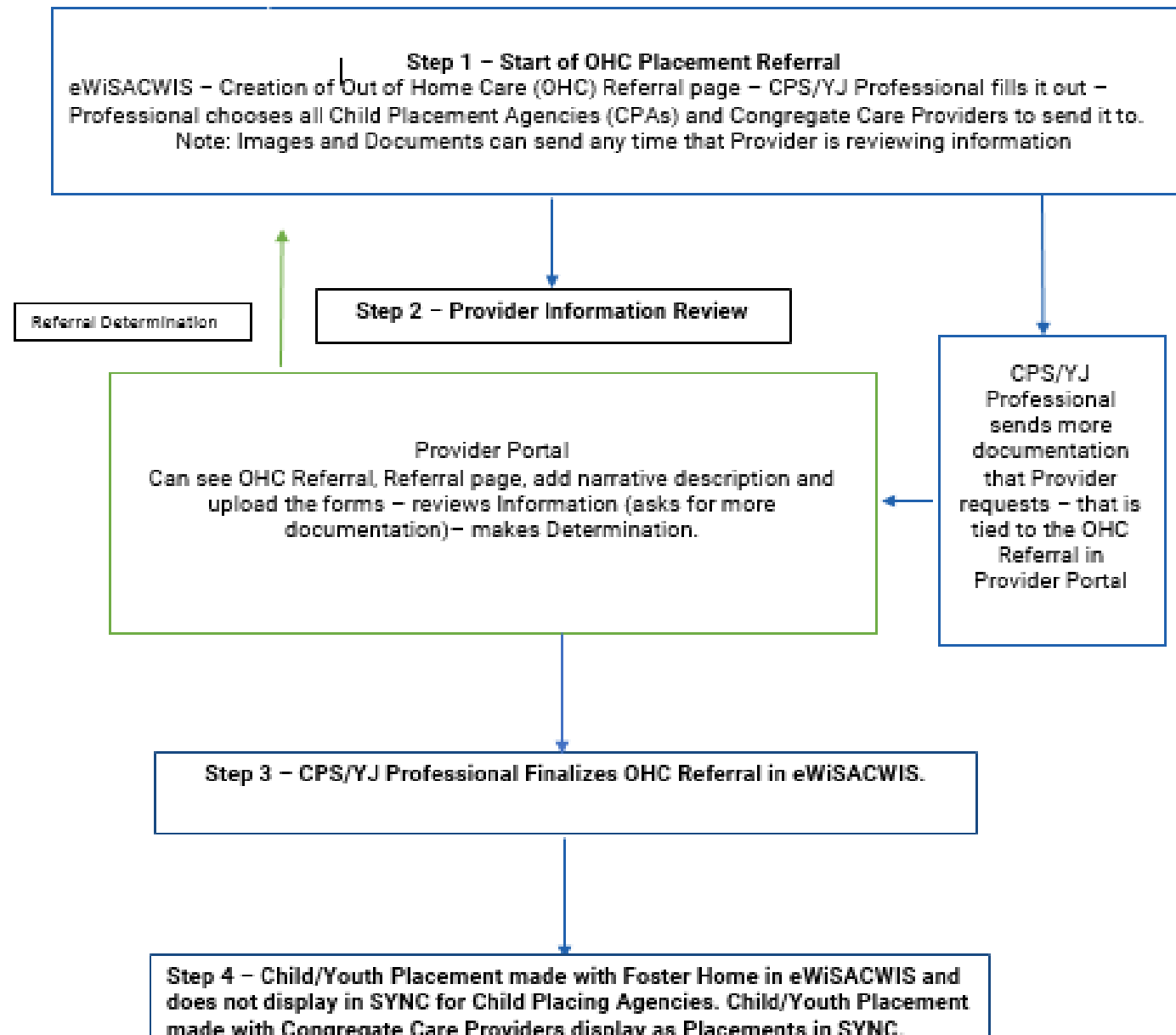

State and federal confidentiality laws that may apply to the contents of this referral include but are not limited to Wisconsin Statutes Chapters 48 (including ss. 48.396, 48.78 and 48.981), 49, 51 (including s. 51.30), 118 (including s. 118.125), 146 (including s. 146.82), 252 (including s. 252.15) and 938 (including s. 938.396 and 938.78), 20 U.S.C. 1232, and 42 CFR Part 2. The information and documents contained in SYNC must be maintained in a manner that would prohibit access by the child/youth, any other children/youth in the care of the provider, and any other party whose access to the information is prohibited. Some confidentiality laws provide penalties for improper access or disclosure, including fines and imprisonment.

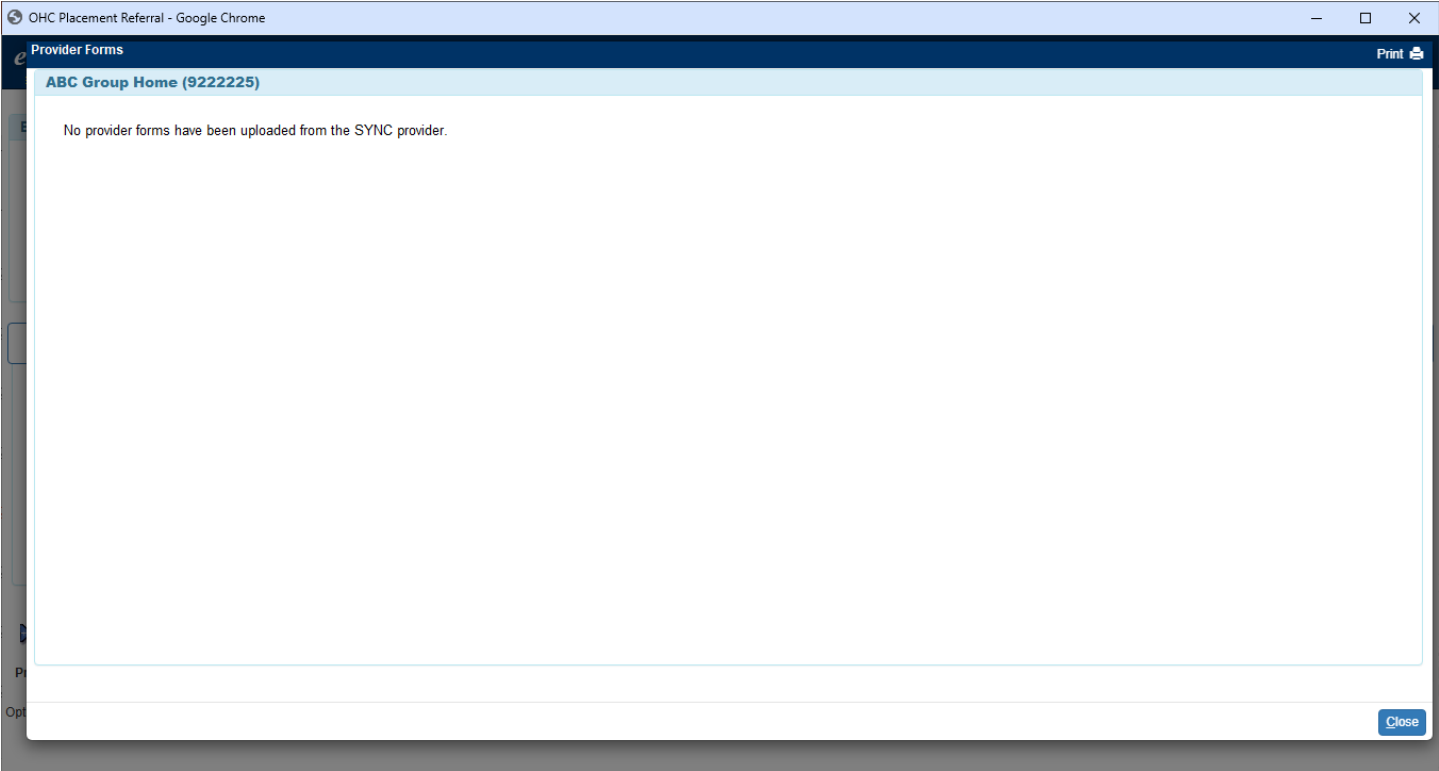

Wisconsin Department of Children and Families

- Redesigned Case Information page to more accurately reflect the work performed by child welfare professionals (CWP) and the flow of a Youth Justice case. When a youth receives multiple referrals, the CWP will be able to group referrals into one intake inquiry and create an episode, which represents an uninterrupted period of time that a youth is involved in the Youth Justice system.
- Once a Youth Justice (YJ) Referral has been linked to a new or existing case, professionals are ready to record the intake recommendation, the DA decision, create or document a DPA, document formal petitions, consent decrees, victim information, restitution, community service, and other Youth Justice Case related work.
- To create a Youth Justice Case Information page, professionals will need to have an assignment to a case with at least one pending YJ Referral linked to it.
