Documenting the DRAI as "Made In Error" also marks the associated piece(s) of work (YJ Referral, JSDR Record (if exists) and Court Hearings row (if exists)) as "Made In Error."  Modifications will be made on Maintain DRAI (Detention Risk Assessment Instrument) page  Added a "Made In Error" checkbox to the DRAI.  Record who checks the checkbox and the time user checks checkbox.  Added an optional narrative to capture the "Reason" for marking the DRAI as "Made In Error."  Added processing to remove the associated pieces of work when user marks the DRAI as "Made In Error."  Modifications will be made to background processing for the YJ Referral page to account for associated DRAI records marked as to "Made In Error."
