Below you will find highlights for the upcoming October 2025 eWiSACWIS release. These highlights include changes that may affect workflow, data entry, procedures, and reporting. Some of the changes are the result of policy changes, legislative changes, eWiSACWIS team input, and issues reported to the eWiSACWIS help desk by users.

IL	48306: Business Purpose: To update the IL Eligibility logic for youth who enter a Guardianship on or after their 16th birthday, so the IL Eligibility calculations better align with policy needs. Extend Independent Living Eligibility to include youth who enter Chapter 48.9795 guardianship in addition to existing categories (Chapter 48.977 and Out-of-State)
