




eWiSACWIS Release Notes

YOUTH JUSTICE	<p>46748:</p> <p>Business Purpose: Redesign Case Information page to more accurately reflect the work performed by child welfare professionals (CWP) and the flow of a Youth Justice case. When a youth receives multiple referrals, the CWP will be able to group referrals into one intake inquiry and create an episode, which represents an uninterrupted period of time that a youth is involved in the Youth Justice system.</p> <p>Modifications were made on the Youth Justice Case Information page:</p> <ul style="list-style-type: none">○ Allows for a single or multiple Intake Inquiry tabs.<ul style="list-style-type: none">▪ Each Intake Inquiry will allow one or multiple referrals to be grouped together. For example, users now will have the ability to group referrals together as youth moves through the intake process.
