1. Introduction

State child welfare programs and those administering child welfare services are responsible for meeting federal reporting requirements associated with their Adoption and Foster Care Analysis and Reporting System (AFCARS).

This document will describe how and where each AFCARS data element is captured in eWiSACWIS.

2. AFCARS Data Entry
