#### Nominations Being Accepted for the Secretary's Caring for Kids Award

### **Safety Planning Revisions Workgroup Wraps Up Phase 1**

Last August, DCF launched the Safety Planning Revision Workgroup. Over the past several months, this self-professed group of 'safety nerds' has been working hard and thinking critically about the language used when talking about safety in the child welfare system.

The focus of Phase 1 for this workgroup has been to look at the present and impending danger threats through a race, equity, and inclusion lens. To guide the conversations, the workgroup used a practical guide developed by the Children's Bureau called: "Buzzwords: Moving to Behavioral Descriptors". This guide outlines some common 'buzzwords' often used in child welfare. Buzzwords are popular jargon or phrases that can be subjective, negative and have the potential to lead to unintended biases.

Based on their work, the Safety Planning Revisions Workgroup is recommending changes to the existing danger threat language to remove subjective buzzwords and phrases. The changes will be 'previewed' to key stakeholders early in 2022 for input and feedback. The revised danger threats will roll out in a Summer 2022 eWiSACWIS release.

#### **Parent Leader Group Information**

Launched in early 2021 by DCF's new Lived Experience coordinator, the Parent Leader Group is now meeting monthly to talk about lived experience and ways to support the child welfare's transformation efforts. This group is made up of parents with lived child welfare experience. The parent leader meetings are being held virtually and facilitated by DCF and the Office for Children's Mental Health (OCMH). For parents that may be interested in joining this group, this form should be completed and submitted. DCF is always looking for more families to work within this group to assist in the transformation efforts.

At the end of 2021, DCF's Lived Experience role was highlighted in State Bar of Wisconsin, Children and the Law Section Blog.

"Attorneys who practice law in the child welfare system play a variety of roles - agency representation, guardian ad litem or youth attorney, parent attorney, judicial officer - but one thing is almost certain: they will have some level of interaction with parents of the children involved in their cases. How much value is given to a parent's perspective or input may vary greatly, but hearing that voice is a vital part to child welfare transformation. While Wisconsin works to implement The Family First Prevention Services Act, a national legislative effort to reduce the number of children in out-of-home care, it is an ideal time to ensure the parent voice is heard."


#### **QRTP Provider Update**
