Registered or Licensed Nursing Staff or other Clinical Staff who:	The Department recognizes that it may not be efficient for every single facility to establish 24/7 nursing staff.
 on site according to the facilities trauma- informed treatment model are available 24/7 	Given the individual needs of all facilities in Wisconsin, DCF plans to offer a 24/7 "telehealth" or "hotline" service to support facilities in meeting the federal requirement. There may be an option for facilities with available nursing staff to "opt out" of this service. DCF has selected a provider for this telehealth service. An announcement regarding the award of this contract will be forthcoming in the next few weeks.
• Sec. 201 (4)(B)	Facilities must have registered or licensed nursing staff and other licensed clinical staff who provide care within the scope of their practice as defined by State law; are on-site according to the treatment model referred to in their trauma informed treatment model and plan; and are available 24 hours a day and 7 days a week.
