Lub Department of Children and Families (DCF) Adoption Assistance Eligibility Coordinator yuav muab daim ntawv thov qhov Initial Rate Determination los xyuas thiab ua kom tiav Ntu (Part 2) ntawm daim foos no thiab muab xa rov qab mus rau lub chaw ua hauj lwm saws me nyuam.
