Qhov no kuj yuav yog tus me nyuam lub tsev kawm ntawv ib tug neeg ua hauj lwm, tus me nyuam tus kws kho mob, tus kws qhia ntawv, qhov chaw zov me nyuam los yog ib tug zoo ib yam li ntawd. Nws tsis yog cov phooj ywg, cov nyob ze ib ncig vaj tse los yog cov txheeb ze.
