

## INITIAL LICENSING CHECKLIST – FAMILY CHILD CARE CENTERS

**Use of form:** Use of this form is mandatory under DCF 250.11(3). Personal information you provide may be used for secondary purposes [Privacy Law, s.15.04(1)(m), Wisconsin Statutes]. **(1) SFTA TC** – This checklist is used by the Supporting Families Together Association Technical Consultant (SFTA TC) to detail the results of the pre-licensing technical assistance. **(2) Applicant** – This checklist is used by the applicant to indicate the center is in compliance with all applicable requirements and to present the results of the pre-licensing technical assistance. The checklist constitutes one part of a complete application and failure to submit it to the department may result in denial of your application. **(3) Licensing Specialist** – The Licensing Specialist uses this checklist during the initial licensing visit to determine whether the applicant meets the minimum requirements to receive a probationary license.

**Instructions:** **(1) SFTA TC** – The Supporting Families Together Association Technical Consultant completes the SFTA TC column and signs the checklist at the end of the pre-licensing process. **(2) Applicant** – The applicant for an initial license completes the Applicant column and signs the checklist not more than 30 days prior to submitting it along with the other application materials to the Department of Children and Families (DCF). **Note:** If the Licensing Specialist makes the initial licensing visit and you are not in compliance with all applicable requirements of DCF 250, your application for a license may be denied because you do not meet the minimum requirements for a license. **(3) Licensing Specialist** – The DCF Licensing Specialist completes the Licensing Specialist column and signs the checklist during the initial licensing visit. The checklist is retained in the facility file.

250.06(2)(n)	<b>RADON TESTING</b> Each licensee shall test or have a test conducted for radon gas levels in the lowest level of the center that is used by children in care for at least 7 hours per week. The test shall be conducted for a minimum of 48 hours with the center’s windows closed and the levels of radon gases shall not exceed 4 picocuries per liter of air. The licensee understand they must meet the requirements for radon testing set forth in 250.06(2)(n)									
250.06(2)(n)4.	<b>RADON MITIGATION</b> The license understands that if the levels of radon gases exceed 4 picocuries per liter of air in the lowest level of the center, the licensee shall notify the parents of children in care and have a radon mitigation system installed, retest for radon gas levels, and submit radon test results to the department within 12 months after the date of the initial test, as specified in 250.06(2)(n)4.

250.06(3)(a)	WRITTEN EMERGENCY PLANS There is a written plan for taking appropriate action in the event of an emergency, including a fire, a tornado, a flood; extreme heat or cold; a loss of building services, including no heat, water, electricity or telephone; human-caused events, such as threats to the building or its occupants; allergic reactions; lost or missing children; vehicle accidents; or other circumstances requiring immediate attention. The plan shall include specific procedure from DCF 250.06(3)(a)1. through 4. The center will practice the fire plan monthly and the tornado plan monthly from April through October with the children and document when the plans were practiced.									
250.06(3)(b)	PRACTICE OF EMERGENCY PLANS The center will practice the fire evacuation plan monthly and the tornado plan monthly from April through October and will document when the plans were practiced.

SMOKE DETECTORS Smoke detectors are installed and maintained in operating condition at the head of every open stairway, on each level of the center, and in all areas used for nap or rest periods. The smoke detector at the head of an open stairway may also serve as the smoke detector for that level of the center.									
250.06(4)(a)3.	SMOKE DETECTORS – TESTING The licensee understands all smoke detectors shall be tested monthly and a record kept of the time, date, and results of the test. A smoke detector shall be immediately repaired or replaced if any unit or part of a unit is found to be inoperative.									
250.06(4)(a)4.	SMOKE DETECTORS - BATTERIES The licensee understands that the battery in a single-station battery-operated smoke detector shall be replaced at least once each year.									
250.06(4)(b)	FIRE EXTINGUISHER An operable fire extinguisher with a minimum rating of 2A-10BC is provided for the kitchen and cooking area. The provider knows how to use the extinguisher and understands to inspect it annually and keep documentation of the inspection on file.
