

**INSTRUCTIONS FOR OBTAINING CHILD WELFARE LICENSING
ADMINISTRATIVE RULES AND ANNOTATED RULE BOOKS**

OUT-OF-HOME CARE ANNOTATED RULE BOOKS: The purpose of the annotated rule book is to help users understand the intent and application of the rule. They are copies of the administrative code from the Revisor of Statutes Bureau that have been formatted with larger print and bound into a booklet. The *italicized* information on the right side of each page is the annotated language that was prepared by staff of the Bureau of Permanence and Out-of-Home Care. Additional appendices have been included to provide important information and guidance.
