#### **Raws li yog ib tus uas tau txais Wisconsin Shares cov nyiaj pab, kuv pom zoo rau cov nqi lus nram gab no:**

Kuv paub txog tas nrho cov cai thiab cov cai tswj hwm nyob hauv Wisconsin Shares qhov kev pab cuam, thiab kuv yuav xyuas thiab ua kom tau raws li cov cai uas muab teev rau hauv Wisconsin Statutes 49.155 hais txog Wisconsin Shares qhov kev pab them nyiaj zov me nyuam, (<http://docs.legis.wisconsin.gov/statutes/statutes/49/III/155>).

Kuv muaj pluaq siab los mus zov cov me nyuam uas koom rau hauv Wisconsin Shares Qhov Kev Pab Them Nyiaj Zov Me Nyuam. Wisconsin Shares Qhov Kev Pab Them Nyiaj Zov Me Nyuam muab nyiaj txhua hli rau cov niam txiv uas siv daim npav MyWIChildCare EBT (Kev Xa Nyiaj Hauv Tshuab Hluav Taws Xob). Kuv to taub tias yuav kom tau txais EBT cov nyiaj them, kuv qhov lag luam yuav tsum kos npe rau ib daim ntawv cog lus nrog DCF tus them cov nyiaj, FIS, uas muaj kuv tus ID naj npawb them se thiab lub tuam txhab tso nyiaj tus as-khauj naj npawb. Kuv to taub tias nws yog ib qho txhaum kev zov me nyuam txoj cai:

- Los mus them EBT cov nyiaj rov qab, txawm yuav yog tas nrho los yog ib feem, rau cov neeg tuav daim npav MyWIChildCare. Yog hais tias yuav tau them ib qhov nyiaj rov qab los yog muab kho kom yog, kuv qhov kev zov me nyuam yuav tsum hu rau FIS tus xov tooj muab kev pab ntawm 1-877-201-7601.
- Los mus muab nyiaj ntsuab, khoom siv, thiab/los yog kev pab (uas tsis yog kev zov me nyuam) rau cov neeg tuav daim npav MyWIChildCare kom rov qab tso cai muab EBT cov nyiaj them rau kuv qhov kev zov me nyuam.
- Los mus hais kom cov niam txiv muab tus Personal Identification Number (PIN) rau lawv qhov EBT tus as-khauj los yog kom muab lawv daim npav EBT tso cia rau kuv qhov kev zov me nyuam los yog tso cia rau ib tus ntawm qhov kev zov me nyuam cov neeg ua hauj lwm.
- Rau kuv qhov kev zov me nyuam los mus hais kom pib ua EBT cov kev them nyiaj sawv cev ib tus niam txiv.

Kuv pom zoo los mus ua kom tau tas nrho raws li cov cai uas muab sau rau hauv cov ntawv ceeb toom Qhia Txog Ntawv Tso Cai Zov Me Nyuam Txhua Hli (Monthly Child Care Authorization Information) thiab txoj cai tswj hwm cov ntaub ntawv/cov cai tswj, nrog rau: ua kom tiav cov foos sau npe nkag tuaj rau zov/sau npe tawm kom yog, thiab khaws cov foos no cia rau hauv qhov kev zov me nyuam; qhia rau qhov chaw khiav hauj lwm zov me nyuam hauv zos paub tias ib tus me nyuam uas tau txais Wisconsin Shares qhov nyiaj pab tsis tuaj rau kuv zov ntxiv lawm thaum paub kiag tias muaj pauv nyob hauv cov me nyuam

tuaj rau zov; thiab yuav zov cov me nyuam tsis coob tshaj qhov txoj cai pub zov, tsis hais cov me nyuam no yuav yog nws niam nws txiv them kheej thiab/los yog cov nyiaj pab them rau.

**Cov zov me nyuam hauv tsev nkaus xwb:** kuv pom zoo ua kom tau raws li ib qhov twg thiab tas nrho cov cai kom luam ntiv tes txheeb xyuas keeb kwm yav dhau los ntawm tus neeg muab kev pab tu lwm tus (fingerprint-based caregiver background check) raws li uas tau muab teev rau hauv s.48.685(2)(br), Wis. Stats. Tas nrho cov tuav daim ntawv tso cai, cov neeg uas muaj hnuv nyoog uas nyob hauv qhov chaw zov me nyuam, cov uas tuaj ua hauj lwm pab dawb uas muab suav rau hauv cov neeg ua hauj lwm zov tau tsawg leej me nyuam (staff-to-child ratios), thiab tas nrho cov neeg ua hauj lwm (18 xyoos thiab tshaj saud) uas yuav tsum tau ua qhov txheeb xyuas keeb kwm yav dhau los yuav tsum tau ua cov kev luam ntiv tes kom tiav.
