### SaintA – Alison McMorrow

Working on placement stability. As of May 8<sup>th</sup>, just five kids short of hitting 90%.

There is a higher percentage of kids placed with kin and like kin.

Working on caregiver support for kinship and foster parents with a CCH grant to support relative care givers.

As part of Family Preservation, will be working with families for 45 days.

Continue to remain committed to Trauma Informed Care. Using the Sanctuary model.

Placement stability in March is near 90%

Number of kids placed with relatives is up to 36% and are continuing to work on this.

- Look at the family first in terms of resources offered and resources that already exist within the family.
- Rather than look at the weaknesses in children focus on their strengths

- Kin support and dealing with trauma. It is likely that kin may share some of the same circumstances as the rest of the family learn and try to break the cycle
- Always keep looking for new solutions never stop thinking that you already have the best solution other possibilities are out there
- Time Monitoring
- Include and strengthen the community voice in context with the welfare system
- Clarify "at-risk" when entering the welfare system. When is too early to intervene and when is too late to intervene?
- Prevent placement disruption: What needs to be in place for placement NOT to be disruptive (wrap around process approach)
- Maximize the use of each other efficiently to eliminate redundancy
- Funding of Primary prevention (i.e. education before CPS contact). Nongovernmental is much more difficult to control (rough and tumble) so we need to be mindful of primary as well as secondary prevention
- What is child welfare across the entire continuum?
- Prevention of long-term issues (focus on kids 0-3) to prevent future needs
- Honor stable forces in individual's lives (this goes back to family/children strengths)
- Keep families intact with things that already work for them
- Approach solutions through the eyes of the family. Give families the answers through community voice and family voice.
- Be innovative and flexible not combative but engaging.
- Build support around families in crisis. Teach family to solve situations to avoid children being placed in out of home care.
- Rethink Safety: removing a child from the home may keep them safe but introduce other trauma
- Legal timeliness
- Highly skilled staff
- Changing community changes trauma
