Section 1: Report of 2021 Activities

1. Please describe the panel's 2021 meeting schedule, including the frequency and type of panel meetings, and the frequency and type of any subcommittee and workgroup meetings.

Our CRP met four times in 2021, all virtually due to the pandemic. As indicated in years' past, we do not have formal sub-committees per se, but we do conduct inter-meeting work via email, sharing updates and work product to seek feedback and approval.

2. Please describe how the panel provided for public outreach and comment in order to assess the impact of current procedures and practices upon children and families in the community.

Our panel reports out our mission and duties to the community through several mechanisms that allow for feedback. For example, we give presentations to local service groups, Human Services Board, law enforcement meetings, and pupil services staffings to raise awareness of our CRP and its mission, as well as to solicit feedback. In past years we were able to have community wide meetings, inviting stakeholders to the table; however, the pandemic did not allow for that in 2021.

3. Please describe any case reviews conducted by the panel in 2021.

Our panel has not traditionally conducted case reviews.

4. Please summarize any other panel activities or panel events that took place in 2021.

Our panel prioritized assisting the Drug Endangered Children/Children in Crisis (DEC) committee to continue evolving by supporting attendance and participation in the National DEC Conference for local law enforcement, as well as Human Services staff. Our panel also purchased two curriculums for use with our local municiple judges and school districts titled "Drugs, Alcohol and Vaping" and "Sexting and Social Media." These are being used proactively with various districts to raise awareness and deter future child welfare involement. We also purchsed copies of Dr. Bruce Perry's book titled "What happened to you?" for use with foster parents in order to increase their understanding of trauma in hopes of reducing turnover in placements. Our panel also felt strongly that we need to continue to support parents during the pandemic so we purchased gas and grocery gift cards for families in need. Finally, we kept the tradition of recognizing staff and all that they do with employee appreciation mugs.

Locally, the panel has witnessed the coordination with law enforcement overall and specifically as it relates to the Drug Endangered Children (DEC) initiitave that was sponsored by the CRP. We have added members of law enforcement to the panel throughout the years and the panel has heard details of the collaboration and execution of the standards as it relates to our law enforcement partners. One final example worthy of note is the case reviews conducted between law enforcement and JCHSD as they debrief DEC cases around what worked well, along with areas of growth for future partnerships.
