The panel met monthly except during the months of July, October, and November. All of our meetings were whole group meetings. Our panel did not have any subcommittee or workgroup meetings.

In 2021 we used our pinwheel display as an opportunity for public outreach and in doing so opened the door for public comment. We construct our pinwheel display along our County Fairground fence which spans an entire block on the main road through Antigo. We received many comments from community partners and citizens as well as attention from local media. These conversations and publications gave panel members opportunities to discuss the reason behind the display and the important message it holds. Many people expressed that they were happy to see the display again after we did not construct the display in 2020, due to COVID-19. The panel revised our Case Study Protocol in the beginning of 2021 and then conducted a mock case review during the month of April, using the revised protocol. The panel planned another case review for October but this was not completed due to only 3 panel members being in attendance. Members present at that meeting thought it was important to have representation from other sectors present in order for the case review to be purposeful and a fair use of the presenting worker's time. Our intention was, and is moving forward, to complete two Case Studies per year, during the months of February and October. Our panel contemplated conducting more case studies but decided we did not want to do more than what

The panel constructed our annual pinwheel display in honor of National Child Abuse Prevention Month. The panel did not coordinate any additional activities for National Child Abuse Prevention Month. Only panel members and CPS staff were invited to help construct the display this year due to pandemic social gathering guidelines. Historically we've invited community partners and elected officials to the event. In recognition of National Foster Care month the panel provided gifts to all foster homes as a token of appreciation and gratitude. Additionally, the panel purchased gifts of appreciation for CPS staff during National Social Worker month. The panel also sponsored a staff development day for CPS staff.

Langlade County CPS reports having a positive working relationship with local law enforcement. The department and law enforcement currently have two MOUs. The first of which is a general MOU for conducting child abuse and neglect investigations. The other MOU was created specifically for child abuse and neglect investigations that involve drug endangered children. These MOUs really impresses upon those involved how to appropriately carry out investigations regardless of the case type. Outside of the MOUs there is positive interaction in day to day work, with law enforcement and social workers collaborating regularly.
