Section 1: Report of 2021 Activities

1. Please describe the panel's 2021 meeting schedule, including the frequency and type of panel meetings, and the frequency and type of any subcommittee and workgroup meetings.

The full CRP committee met six times or bimonthly throughout 2021. The CRP Executive Committee comprised of the Chair, Vice-Chair, Director of DSS and CRP Coordinator (Child Welfare Manager) also met bimonthly. Subcommittees met as needed throughout the year. In addition, individual education sessions were provided to CRP members regarding Child Protectice Services standards to prepare for CPS case reviews.

2. Please describe how the panel provided for public outreach and comment in order to assess the impact of current procedures and practices upon children and families in the community.

Marathon County's CRP participated in several community events in 2021. We partnered with The Womans Community and the Child Advocacy Center for Child Abuse Awareness month, providing materials and a coloring contest for 3rd grade students. Additionally, the Marathon County CRP participated in Children's Fest in which the panel displayed a message board providing information about the CRP. Pinwheels were shared with children, and CRP approved written materials about keeping kids safe were shared with families.

3. Please describe any case reviews conducted by the panel in 2021.

A summary of the reason for ongoing CPS involvement was provided as well as the out of home placement information (including location of placement, length of placement and permanency outcome) and services provided to the family were reviewed. Additionally, strengths and complicating factors as identified by MCDSS were reviewed with the panel members. Following the case review, the panel had an opportunity to have a discussion surrounding the purpose of the review, which is to discover systemic issues within the scope of the CRP's mission and mandates.

CPS and Tribal CW Agencies

DCF exhibited strong leadership in their coordination and support of an Organizational Effectiveness (OE) initiative that sought to improve the relationships and connections between them, county child welfare agencies and tribes in 2021. The initiative resulted in several action items to improve the collaboration and coordination of ICWA cases in Wisconsin. Examples range from refreshing ICWA resources for county child welfare staff to a more involved action plan to develop structured ways to have formal collaboration on systems issues at a leadership level. DCF continues to express support for the work that resulted from the OE initiative.

DCF has continued to focus on ensuring our case review process aids us in learning about elements that could be improved upon within our practice and has rolled out workgroups to focus on identified areas. The Safety Action Workgroup has provided recommendations to the Continuous Quality Improvement committee (CQI) with recommendations at system level as this drives local level work. Significant focus has been placed on making improvments to Wisconsins safety planning process, which will impact all areas of CPS.

Chosen CPS Responsibility #1

Marathon County's Multidisciplinary teams are generally compromised of individuals from Law Enforcment, Domestice Abuse programming, and Health Care professionals. MOU's are regularly updated with these partners to ensure postiive working relationships and collaboration for the famililes we serve. Specific cases are reviewed on a consistent basis to ensure a seamless coordinated care effort and policies and proceedures are updated as needed.

Chosen CPS Responsibility #2

With the rollout of FFPSA in October 2021 many local efforts have addressed the philosopical change that will need to occur with community partners to move this initiative forward. The Child Welfare agency has participated in the Judicial Engagement Team (JET) which brings partners on board and have engaged in multiple agency discussions around how to successfully accomplish this. Staff have also held retreats to talk specificilally about further integrating family participation in case planning and also about how to recognize our own bias'. High level overviews of these initiatives supporting Family First Prevention Services Act have been shared with the CRP.

Recommendation 1	We are aware of the significant need for services for children and families whos children have complex care needs. Often, these children end up in very high level (often out of state) placements.
Recommendation 2	As we seek least restrictive placements, we recommend flexible alternatives for licensing of foster parents and kinship homes. The definition of kinship in support of family first is not the same definition wherein formal financial support can be offered to assist natural supports in maintaining these children.

Continued funding and flexibility around programs like TSSF are important to continue. These funding sources aid in maintaining families together and have helped to maintain children upon being reunified. Additionally, we advocate for the state to supply direct funding to counties for preventative programming, such as intensive in home services. Often, these programs are extremely costly to get started and counties do not have the funds alone to get these programs started.

2. Please list any panel recommendations to improve child protection services at the local level.

Recommendation 1	With our initiation of our CRP case review, one early lession was the importance of staff retention and avioiding reassignment of social workers as this contributed to a delay in perm and our CRP is committed to supporting the workforce to the degree they are able.
Recommendation 2	We will continue to seek support from our community in the philosophical shift regarding maintaining children in their homes and identification of supports and resources to make that aim possible.
