The panel met on a monthly basis with meetings occurring the 1st Thursday of the month from 8:00am to 9:00am. There were 10 meetings in 2021, as the committee did not meet in March or July. Due to COVID-19 and agency policies, these meetings have occurred over Zoom with each panel member in their own home/office. There were no subcommittee or workgroup meetings that occurred this year.

Public outreach was difficult due to COVID-19 restrictions and limitations. However, the CRP was able to complete public outreach through multiple projects that benefited the foster care families throughout the county, as well as local nonprofits and school districts. Additionally, the CRP was able to assess current procedures through the case reviews that occurred.

Polk County completed two case reviews. The first case reviewed occurred on 3/11/21 and was related to a successful Child Protective Services (CPS) case. The second case reviewed was related to intergenerational involvement within the county system and occurred on 10/20/21. Polk County did not have a child death, serious injury, or egregious incident.

Act 78 and Systems Chang

Act 78 requires the state to notify the public of child death, serious injury, and egregious or critical incidents due to maltreatment or suspected maltreatment. This appears to be effectively done through the email notifications of incidents. From that information the county is able to complete a case review with all participants. Polk County has used this information to guide their CRP case reviews

Chosen CPS Responsibility #2

CPS and Child Abuse Prevention

Targeted safety support funds (TSSF) contracts to utilize funds from the state to try and keep children in their home. Polk County has been able to utilize these funds to assist a variety of services/supports for families. Funds increased last year and Polk County consistently exceeds the allotted amount on children's protective plans and safety needs. Some examples of how Polk County has used the funds include hiring a cleaning company to clean the home of a family, paying rent for a month, assisting with heating and electrical bills, AODA testing/treatment for parents, and repairing cars so parents can attend scheduled appointments.

Chosen CPS Responsibility #1

CPS and Law Enforcement

Polk County currently rejuvenated DEC (Drug Endangered Children) procedures. During the past year, local agencies have held monthly meetings to discuss procedures and staff cases regarding child abuse, sexual abuse, and neglect cases. Local Child Protective Services (CPS) agency works collaboratively with members of the Drug Endangered Children (DEC) team (i.e., sheriff's office, municipalities, detectives, DA office, etc.) to staff cases pertaining to search warrants and drug endangered children to ensure coordination and collaboration. Additionally, a Handle with Care initiative has been started with two school districts.

Chosen CPS Responsibility #2

CPS and Tribal CW Agencies

Local Department of Children and Families (DCF) workers meet quarterly with local tribal departments and discuss and provide updates on cases that are in common and discuss ways to improve communication between agencies/programs. This has been a successful collaboration as local tribes have taken full jurisdiction of some cases.

Recommendation 1	The current rule on relative placement through ICPC be changed to allow county workers to place with fit and willing relatives in other states prior to the completion of the ICPC process. This would especially be helpful as we are a boarding county with Minnesota and many of our family relatives live near the Twin Cities (which is less than an hour away).
Recommendation 2	Allow tribes to have full access to eWISACWIS so they can complete needed case notes and case work. Through the above noted collaboration with tribal leaders and Polk County Department of Children and Families, this has become evident as a needed change in order to improve collaboration.

Recommendation 1	Allow tribes to have full access to eWISACWIS so they can complete needed case notes and case work. Through the above noted collaboration with tribal leaders and Polk County Department of Children and Families, this has become evident as a needed change in order to improve collaboration.
Recommendation 2	Polk County CRP recommends that Handle with Care be implemented throughout the county with all 8 school districts, Head Start, and Northwest Journey (day treatment program). To provide a trauma informed approach to communication regarding the wellbeing of children.
