Section 1: Report of 2021 Activities

1. Please describe the panel's 2021 meeting schedule, including the frequency and type of panel meetings, and the frequency and type of any subcommittee and workgroup meetings.

During the year of 2021, the Wisconsin State Youth Advisory Council (YAC) has worked hard to maintain regular meetings throughout the entire year amongst the local YAC regions as well as state meetings. This was a challenge due to the pandemic impacting the ability to meet in person for the majority of the year. During the summer months some local YACs and a state YAC meeting found the ability to have in-person meetings during the summer when the weather was nice which was a big step toward getting back into inperson in general. State YAC members hold the goal of meeting on a quarterly basis at the statewide council. YAC was unable to attend the Daniel Memorial Conference as well as the National Citizen Review Panel Conference due to the pandemic.

In absence of these annual conferences; we started the conversation about doing a main initiative for the following year 2022. The State Youth Advisory Council's past main initiative was to work on extending Independent Living services to the age of 23. This initiative was deemed fit for discussion once again since it is a top priority for many young adults in care. Of course other initiatives were spoken of; since attendance was a hit and miss discussion on one initiative seemed at that time; a good use of resources that we had.

State YAC was periodically active on their facebook page sharing and educating the public about foster youth and the system they live in. The State YAC struggled last year with public outreach due to being only able to meet over zoom for so long. There are many plans for change in 2022!

YAC members participated in their Annual Hands Around the Capitol event. This event focuses on the difficulties experienced by foster youth. The State Youth Advisory Councils has worked on implementing ways to improve the safety and stability of youth placed into Relative or Foster Care. Due to low attendance and less discussion the plan for 2022 is to do more outreach in regards to safety in the foster care system.

Like stated previously in the 2020 CRP report many social workers and Independent Living Coordinators are knowledgeable in safety and stability of children placed in relative or foster care. Many IL workers are experiencing a housing issue when safety and stability is not met in homes. This is discussed in the State YAC meetings frequently in hope to continue in sharing local resources.

One of our local YACs participated in a Anti-Human Trafficking event that included a guest speaker who shared her experience, as well as resources and what to do when you are or suspect another individual is involved in human trafficking.

Recommendation 1	The YAC recommends for the state to implement Independent Living Services through the age of 23. This would guarantee continued care for the young adults who receive an Independent Living Worker before and after the age of 21. State YAC has been informed by other Independent Coordinator workers that many of their youth don't go to them until they have reached the age of 18-21 so services for many of them have stopped or have been shown to be "too late" due to a certain age.

2. Please list any panel recommendations to improve child protection services at the **local level**.

Recommendation 1	The YAC recommends local agencies to continue to advocate for Independent Living Resources to be increased from the age of 21 to the age of 23. This would help with college expenses, housing, food security and more.
Recommendation 2	Increased education to potential foster parents to help find better homes for youth who end up in care.
