YOUR CHILD CARE – IS IT LEGAL?

Qhov tso koj tus me nyuam rau lwm tus zov yog ib txoj kev txiav txim siab tseem ceeb heev. Siv sij hawm ua ntej koj xaiv qhov chaw zov me nyuam kom paub tseeb tias qhov chaw yeej ua raws cai tiag. Ntawm no yog ib co xov uas yuav pab qhia kom koj paub seb koj qhov chaw zov me nyuam puas yuav tsum muaj ntawv tso cai.

LUB XEEV TXOJ CAI – Chapter 48.65, WI Statutes

Tsis kheev ib tug neeg twg zov me nyuam tau nyiaj thiab saib xyuas rau 4 tug me nyuam los yog tshaj saud uas tsis tau nto hnuv nyoog 7 xyoo tsawg dua 24 teev ib hnuv twg tshaj tias ntshes tus neeg ntawd muaj ntawv tso cai khiav ib qhov chaw zov me nyuam los ntawm Department of Children and Families.

THAUM TWG THIAJ YUAV TSUM COJ RAWX TXOJ CAI NO

Yuav tsum coj raws txoj cai no thaum zov 4 tug me nyuam los yog tshaj saud uas tsis tau nto hnuv nyoog 7 xyoo rau tib lub sij hawm twg **thiab**:

- Qhov zov nyob tawm ntawm tus me nyuam lub tsev mus
- Tus neeg zov me nyuam tsis yog ib tug txheeb ze thiab tsis yog tus neeg muaj cai saib xyuas
- Leej niam leej txiv tsis nyob rau ntawm qhov chaw zov
- Tus neeg zov me nyuam tau nyiaj them rau nws cov hauj lwm zov me nyuam
- Qhov zov me nyuam tsawg dua 24 teev ib hnuv twg

THAUM TWG THIAJ TSIS TAS COJ RAWX TXOJ CAI

Tsis tas muaj ntawv tso cai thaum:

- Qhov zov nyob rau hauv tus me nyuam lub tsev
- Tus neeg zov me nyuam yog ib tug txheeb ze los yog ib tug neeg muaj cai saib xyuas
- Leej niam leej txiv nyob rau ntawm qhov chaw zov tuaj mus kav khw, ua kev lom zem ua si los yog lwm yam uas tsis yog ua hauj lwm (non-work activities)
- Qhov zov yog pab zov los ntawm ib lub tsev kawm ntawv dawb los yog kawm ntawv ntiav
- Kev saib xyuas yog rau tej lub sij hawm mus ua tej yam xws li mus koom kev kawm, koom nrog koom haum pab pawg los yog ntaus pob ncaws pob
- Qhov zov yog raws cai nyoog, xws li thaum so es kawm vaj lug kub (vacation bible schools) thiab thaum pab zov rau cov hnuv caiv (holiday child care programs)
- Ib lub county, city, village, town, tsev kawm ntawv, los yog tsev qiv ntawv muaj cov kev lom zem ua si los yog kev kawm txog neeg lub neej rau sawv daws mus koom (recreational or social programs).

TSIS MUAJ CAI TSWJ RAU

- Txhua tus neeg uas zov 1 txog 3 tug me nyuam nyob rau hauv tus neeg zov lus tsev (kev muaj ntawv pov thawj zov yog nyob ntawm siab yeem, thiab tsis tas muaj yog zov 3 tug me nyuam los yog tsawg dua)
- Cov neeg pab zov me nyuam los yog cov neeg coj tuaj pab zov me nyuam nyob rau hauv tus me nyuam lub tsev
- Tus neeg pab zov me nyuam uas yog ib tug txheeb ze los yog tus neeg muaj cai saib xyuas
- Cov pab pawg me nyuam qib hnuv nyoog kawm ntawv, tag nrho lawv muaj hnuv nyoog loj dua 7 xyoo

CHAW ZOV ME NYUAM MUAJ NTAWV TSO CAI

- Cov chaw zov me nyuam yav nruab hnuv nruab zoo (day camps) – 4 tus me nyuam los yog tshaj saud hnuv nyoog 3 xyoo thiab loj dua hauv ib txoj kev zov me nyuam raws cai nyoog tawm rau nruab zoo (out-of-doors)
- Cov chaw zov me nyuam hauv tsev – 4 txog 8 tus me nyuam
- Cov chaw zov me nyuam ua pab pawg – 9 tus los yog ntau tshaj saud
