Cuaj Hli Tim 1	Chav Department tso tawm tus nqi them siab tshaj plaws txhua txhua hnuv rau ib hom muaj kev tu (provider) twg.
Kaum Hli Tim 1	Tag nrho cov chaw ua hauj lwm xa daim ntawv thov tus nqi them (proposed rate) uas yog siv daim ntawv F-2696-E rau ntawm hnuv vas thib no los yog ua ntej hnuv vas thib no . <i>Yog xa tuaj tsis ncav hnuv tau teev cia no ces tus neeg muaj kev pab tu yuav tsis muaj txoj cai los mus sib khom kom haum tus nqi them. Yog tus neeg tuav daim ntawv tso cai (licensee) tsis xa tag nrho cov ntawv uas nws yuav tsum tau xa raws li Chapters 52, 54 and 57, lub department kuj yuav tsis pub nws ua ntiv lawm thiab yuav muaj kev nplua raws li cov cai Administrative Rules and s. 48.715, Stats, thiab kuj yuav tshem daim ntawv tso cai tsis pub rau nws lawm.</i>
Kaum Hli Tim 1-31	Chav Department saib daim ntawv thov tus nqi them (proposed rate) uas cov chaw ua hauj lwm xa tuaj. Daim ntawv thov tus nqi them (proposed rate) kuj yuav muab coj los sib khom kom haum ntawm chav Department thiab lub chaw ua hauj lwm thaum lub sij hawm no.

Kaum Ib Hlis Tim 1	Thaum txog hnuv vas thib no lawm, chav Department yuav qhia rau cov chaw ua hauj lwm paub txog tus nqi them uas lawv pom zoo. Yog tias lub chaw ua hauj lwm tsis lees txais raws li tus nqi them uas tau pom zoo, lub chaw ua hauj lwm kuj thov tau kom muaj ib qhov kev sib tham sib khom kom haum tsis pub dhau 5 hnuv thaum tau txais daim ntawv qhia txog tus nqi them uas tau pom zoo los ntawm chav Department. Daim ntawv xa tuaj qhia no yeej muaj cov ntaub ntawv txog qhov kev sib khom kom haum (mediation) txog tus nqi them. Yog tias sib khom tsis sib haum, chav Department yuav yog tus txiav txim siab txog tus nqi them.
