

# Child Care Provider Portal Fact Sheet

The **Child Care Provider Portal (CCPP)** allows you to manage your child care business online. The Provider Portal is available 24/7, and you can access it from any computer, tablet, or smartphone with an Internet connection. You will be able to do the following:

- View the list of children authorized by Wisconsin Shares subsidy program to attend your program.
- View Wisconsin Shares payments made by families using the MyWICChildCare EBT card.
- View and update your child care prices.
- Request to end an authorization for a child who is no longer attending or has never attended your program.
- Report temporary closures so a parent can request an authorization to an alternate provider.
- View certain Licensing/Certification, YoungStar documents and details.
- Submit background checks for your program and view their statuses.
- Receive Wisconsin Shares notices and other communication.
- Send messages to and receive messages from your local agency worker.
