



Barred Offenses – Residential Care Centers, Group Homes, Shelter Cares, and Child Placing Agencies

These tables list crimes and other offenses and their impact on a person's ability to operate, work at, or live as a non-client resident in residential care centers, group homes, shelter care facilities, and child placing agencies.

Regulatory approval, employment, nonclient residency at, and contracting with an entity are barred as follows:

Other Offenses that Require Rehabilitation Approval	
Finding by a governmental agency of abuse or neglect of a client, or of misappropriation of a client's property	
Finding by a governmental agency of child abuse or neglect	

Under Ethan's Law, residential care centers, group homes, shelter care facilities, and child-placing agencies are barred from employing or contracting with a caregiver or congregate care worker who has been charged with any of the offenses below if the charge was pleaded no contest to or was dismissed or amended as part of a plea agreement. These same prohibitions apply to nonclient residents.
