Vim li cas CPS thiaj li ntsig txog rau kuv thiab kuv tsev neeg?

Child Protective Services (Cov Kev Pab Cuam Tiv Thaiiv Me Nyuam Yaus) (CPS) yog tau txais kev tswj hwm los ntawm koj lub koom haum nyiaj pab saib xyuas kev noj qab haus huv rau tus me nyuam yaus hauv zos. Thaum tus kws tshaj lij CPS cuam tshuam nrog koj thiab koj tus me nyuam/cov me nyuam yaus, nws yuav yog vim lub koom haum uas tau txais cov ntaub ntawv hais tias koj tus me nyuam yuav raug tsim txom, tsis saib xyuas, los sis muaj kev pheej hmoo raug tsim txom los sis tsis saib xyuas.

Yog xav kom CPS muaj feem xyuas nrog tsev neeg, cov kev txhawj xeeb uas tau piav qhia ntawm [Kev Nkag Mus Tau](#) yuav tsum ua kom tau raws li kev cai lij choj txhais tau tias yog kev tsim txom los sis tsis saib xyuas. Yog tias nws ua li ntawd, qhov xwm txheej no yuav raug "tshuaj ntsuam xyuas hauv" thiab lub koom haum CPS yuav pib [Initial Assessment \(Kev Ntsuam Xyuas Xub Thawj\)](#).

Kuv tuaj yeem cia siab tias yuav muaj dab tsi tshwm sim tau thaum lub sij hawm muaj Initial Assessment (Kev Ntsuam Xyuas Xub Thawj)?

CPS cov kws tshaj lij muaj 60 hnub los ua kom tiav Initial Assessment (Kev Ntsuam Xyuas Xub Thawj) (IA) thiab txiav txim siab txog cov kauj ruam tom ntej. Hauv qee qhov xwm txheej, nws yuav siv sij hawm tsawg dua, thiab qee zaus nws tuaj yeem siv sij hawm ntev dua 60 hnub. Cov laj thawj tshwj xeeb tias vim li cas qhov no thiaj li yuav tshwm sim nyob ntawm koj lub cheeb tsam nroog, thiab koj raug txhawb kom tham txog qhov no nrog tus kws tshaj lij CPS uas koj tau cuam tshuam nrog.

Thaum lub sij hawm Initial Assessment (Kev Ntsuam Xyuas Xub Thawj), tus kws tshaj lij CPS yuav:

- Tham nrog koj, koj cov me nyuam, thiab lwm tus neeg uas nyob hauv koj lub tsev
- Kawm paub txog koj tsev neeg thiab koj yuav ua li cas kom koj cov me nyuam muaj kev nyab xeeb
- Sib sau cov ntaub ntawv hais txog kev tsim txom los sis tsis saib xyuas uas tau hais
- Tau txais kev nkag siab zoo ntawm koj tsev neeg qhov kev muaj peev xwm thiab kev xav tau
- Mus ntsib tsev neeg kom nkag siab zoo txog qhov kev txhawb nqa koj tsev neeg yuav xav tau dab tsi txog kev txhawj xeeb txog kev nyab xeeb
- Tham nrog lwm tus neeg, yog tias xav tau, xws li cov kws kho mob thiab cov kws qhia ntawv
- Nug seb koj tus me nyuam los sis tsev neeg puas muaj keeb kwm yog Neeg Mes Kas Xeeb Txawm, thiab koom tes nrog koj tus me nyuam pab pawg neeg yog tias lawv yog me nyuam yaus Neeg Khab

Tus kws tshaj lij CPS yuav kawm paub ntau ntixiv txog txhua tus neeg hauv koj lub tsev uas yog ib tus neeg thiab tag nrho tsev neeg. Tus kws tshaj lij CPS saib xyuas kev txhawj xeeb txog kev nyab xeeb, kev saib xyuas niam txiv, nrog rau sij hawm thiab txoj hauv kev uas koj yuav tiv thaiv koj tus me nyuam li cas rau kev ua tiav. Siv cov ntaub ntawv no, lawv txiav txim siab ob qho sib cais tib si:

1. Puas muaj kev tsim txom los sis tsis saib xyuas tshwm sim rau tus me nyuam/cov me nyuam raws li txoj cai lij choj ntawm lub xeev?
2. Tus me nyuam/cov me nyuam puas muaj kev nyab xeeb hauv tsev neeg?

Lub hom phiaj ntawm tus kws tshaj lij CPS yog ua kom cov me nyuam muaj kev nyab xeeb thiab cov tsev neeg hnov tau tias muaj kev txhawb nqa. Yog tias nws tau txiav txim siab tias koj tus me nyuam tsis muaj kev nyab xeeb, cov kws tshaj lij CPS yuav ua hauj lwm nrog koj thiab koj tsev neeg los tsim ib txoj phiaj xwm rau koj tus me nyuam kom muaj kev nyab xeeb. Cov phiaj xwm no hu ua Txoj Phiaj Xwm Kev Tiv Thaiiv los sis Txoj Phiaj Xwm Kev Nyab Xeeb. Txawm hais tias hom phiaj xwm twg tau muab tso rau, tus kws tshaj lij CPS yog lub luag hauj lwm los pab cov niam txiv thiab cov neeg saib xyuas kom cov me nyuam nyob hauv lawv lub tsev muaj kev nyab xeeb, thaum twg los tau, thiab ua kom muaj kev sib raug zoo rau tsev neeg, kab lis kev cai, thiab zej zog. Txawm hais tias lawv tuaj yeem txawv ntawm qhov chaw mus rau qhov chaw, muaj ntau yam peev txheej thiab cov kev pab cuam, thiab nws yog ib feem ntawm tus kws tshaj lij CPS lub luag hauj lwm los ua hauj lwm nrog koj los nrhiav thiab siv cov kev txhawb nqa uas yuav pab koj tsev neeg. **Koj tau txais kev txhawb kom nug txog kev txhawb nqa thiab cov kev pab cuam uas koj hnov tau tias koj xav tau.**

CPS muaj lub hwj chim fab txoj cai lij choj twg los xam phaj kuv tus me nyuam?

Ntu 48 ntawm Wisconsin Cov Cai Tswj Hwm yog hu ua [Cov Me Nyuam Yaus Txoj Cai](#). Raws li [Wis. Stat. § 48.981\(3\)\(c\)1.b.](#) “[t]ej zaum lub koom haum [CPS] yuav tiv tauj, saib xyuas los sis xam phaj tus me nyuam ntawm txhua qhov chaw Yam tsis tau txais kev tso cai los ntawm tus me nyuam leej niam leej txiv, tus neeg saib xyuas los sis tus neeg saib xyuas raug cai yog tsim nyog los txiav txim seb tus me nyuam puas xav tau kev tiv thaiv los sis kev pab cuam, tshwj tsis yog tus neeg ua hauj lwm tshawb xyuas tuaj yeem nkag mus tau rau hauv tus me nyuam lub tsev tsuas yog tau txais kev tso cai los ntawm tus me nyuam leej niam leej txiv, tus neeg saib xyuas los sis tus neeg saib xyuas raug cai los sis tom qab tau txais tsab ntaww txiav txim plaub ntug tso cai rau tus neeg ua hauj lwm.” Cov kws tshawj lij CPS tsis muaj tib txoj cai lij choj los xam phaj cov me nyuam yaus ntawm qee yam khoom ntiag tug uas lawv muaj nyob rau hauv cov chaw pej xeem.

Cov Niam Txiv thiab Cov Neeg Saib Xyuas Neeg Khab Saib Xyuas Me Nyuam Yaus Neeg Khab

Raws li txoj cai lij choj, [Wis. Stat. § 48.02\(8g\)](#), ib tus me nyuam Neeg Khab yog ib tus neeg tsis tau sib yuav uas muaj hnub nyooq qis dua 18 xyoo uas yog ib tug tswv cuab ntawm ib pab pawg neeg Khab los sis tsim nyog ua tswv cuab hauv ib pawg neeg Khab thiab yog tus me nyuam yug ntawm ib pawg neeg Khab. Indian Child Welfare Act (Tsab Cai Hais Txog Nyiaj Pab Rau Kev Noj Qab Haus Huv Rau Tus Me Nyuam Neeg Khab) (ICWA) thiab Wisconsin Indian Child Welfare Act (Tsab Cai Hais Txog Nyiaj Pab Rau Kev Noj Qab Haus Huv Rau Tus Me Nyuam Neeg Khab Ntawm Wisconsin) (WICWA) yog npaj los “tiv thaiv qhov zoo tshaj plaws ntawm cov me nyuam yaus Neeg Khab thiab txhawb kev ruaj ntseg thiab kev ruaj ntseg ntawm cov pab pawg neeg thiab cov tsev neeg uas yog Neeg Khab.” ICWA thiab WICWA kuj tseem muab kev tiv thaiv qee yam rau koj, raws li niam txiv los sis tus neeg saib xyuas Neeg Khab ntawm ib tus me nyuam yaus Neeg Khab, thiab cov kev cai rau lub xeev thiab cov koom haum CPS ntawm cheeb tsam nroog.

Lub koom haum CPS yuav tsum koom nrog pawg neeg ua hauj lwm thaum lub sij hawm IA thiab txhim kho cov phiaj xwm nrog rau tsev neeg. Yog li ntawd, **koj yuav tsum qhia rau txhua tus kws tshaj lij CPS uas koj muaj kev tiv tauj nrog koj tus me nyuam cov xeeb ntxwv Neeg Mes Kas Xeeb Txawm**. Qhov no yuav pab cov kws tshaj lij CPS nkag siab seb ICWA/WICWA puas siv tau. Yog tias koj muaj lus nug, sib faib qhia rau lawv thoob plaws lub ncua sij hawm ntawm lub koom haum nyiaj pab kev noj qab haus hauv rau me nyuam yaus.

Kuv tus me nyuam puas yuav raug tshem tawm hauv tsev?

Feem ntawm Initial Assessments (Kev Ntsuam Xyuas Xub Thawj) kaw yam tsis muaj kev txhawj xeeb txog kev nyab xeeb los sis tus me nyuam raug tshem tawm. Txawm li cas los xij, thaum muaj kev hem thawj rau kev nyab xeeb uas yuav tsum tau daws, cov koom haum CPS hauv zos sim ua kom tsev neeg nyob ua ke. CPS tus kws tshaj lij yog lub luag hauj lwm rau kev ua hauj lwm nrog koj txhawm rau txheeb xyuas cov kev pab cuam uas yuav ua rau koj tus me nyuam muaj kev nyab xeeb thiab koj tsev neeg ua ke. Qee zaum cov kev pab cuam no tsis tuaj yeem muab rau hauv tsev. Thaum qhov no tshwm sim, tus kws tshaj lij CPS yuav tham nrog koj thiab koj tsev neeg:

- Nrhiav qhov chaw nyab xeeb ib ntus rau koj tus me nyuam nyob nrog cov txheeb ze los sis cov phooj ywg los sis hauv tsev tu me nyuam
- Npaj kom koj saib pom koj tus me nyuam hauv 5 hnub ua hauj lwm tom qab lawv qhov kev tshem tawm ntawm koj lub tsev
- Txuas koj thiab koj tus me nyuam mus rau cov kev pab cuam txhawb nqa nrog lub hom phiaj ntawm lawv rov qab mus rau koj qhov kev saib xyuas, kuj tseem hu ua kev sib koom ua ke



Thaum muaj xwm txheej ceev, koj tus me nyuam yuav raug tso tawm sab nraum koj lub tsev yam tsis tau txais koj qhov kev tso cai. Lub rooj sib hais hauv tsev hais plaub yuav tsum muaj nyob rau hauv 48 teev tom qab tau txiav txim siab tshem tawm koj tus me nyuam. Ntawm lub rooj sib hais Temporary Physical Custody (Kev Saib Xyuas Lub Cev Ib Ntus) (TPC) no, lub tsev hais plaub txiav seb koj tus me nyuam puas yuav tsum nyob sab nraum koj lub tsev. Koj yuav tau txai kev qhia tias lub rooj sib hais yuav tuav nyob rau thaum twg thiab qhov twg, thiab txhawb kom koj tuaj koom qhia lub tsev hais plaub seb koj saib pom qhov xwm txheej li cas.

Yog tias koj yog niam txiv los sis tus saib xyuas Neeg Khab ntawm Ib Tus Me Nyuam Neeg Khab, [txoj cai lij choj ntawm Wisconsin](#) hais tias koj muaj txoj cai los sawv cev los ntawm tus kws lij choj yog tias koj tus me nyuam raug tshem tawm ntawm koj qhov kev saib xyuas. Thov qhia mus rau tshooj kawg ntawm daim ntawv no kom paub txog kev txhawb nqa kev cai lij choj.

Yog tias koj tus me nyuam raug tshem tawm ntawm koj qhov kev saib xyuas, thov mus saib [Kev Taw Ohia rau Nyiaj Pab Kev Noj Qab Haus Huv Rau Tus Me Nyuam – Rau Cov Niam Cov Txiv, Los Ntawm Niam Txiv](#) kom paub ntawm. Cov txiaj ntsig tau los ntawm Initial Assessment (Kev Ntsuam Xyuas Xub Thawj)

Thaum ua tiav qhov Initial Assessment (Kev Ntsuam Xyuas Xub Thawj) tus kws tshaj lij CPS yuav sau ib daim ntawv qhia uas piav qhia txog qhov tau ua tiav thiab cov ntaub ntawv sau tseg. Raws li kev nyab xeeb ntawm tus me nyuam/cov me nyuam yaus, ib qho ntawm cov txiaj ntsig uas tau tshwm sim yuav tshwm sim:

Nyab Xeeb - Kaw Rooj Plaub:

Tus kws tshaj lij CPS txiav txim siab tsis muaj kev txhawj xeeb txog kev nyab xeeb, muab cov ntaub ntawv qhia txog kev nkag mus tau rau hauv zej zog, yog tias xav tau, thiab rooj plaub raug kaw.

Nyab Xeeb - Qhib Rooj Plaub nrog Cov Kev Pab Cuam Kev Yeem Ntawm Siab:

Tus kws tshaj lij CPS txiav txim siab tsis muaj kev txhawj xeeb txog kev nyab xeeb, tab sis koj, niam txiv, tuaj yeem xaiv qhib rooj plaub thiab tau txais kev pab cuam CPS nyob ntawm siab yeem. Tus kws tshaj lij CPS yuav txheeb xyuas koj thiab koj tsev neeg ntawm ib lub sij hawm mus rau ib lub sij hawm.

Tsis Nyab Xeeb - Qhib Rooj Plaub nrog Kev Tiv Thaiv/Txoj Phiaj Xwm Kev Nyab Xeeb:

Tus kws tshaj lij CPS ua hauj lwm nrog tsev neeg los tsim Txoj Phiaj Xwm Kev Tiv Thaiv los sis Kev Nyab Xeeb uas pab kom ntseeg tau tias muaj kev nyab xeeb hauv koj lub tsev los sis txav koj tus me nyuam mus rau ib lub tsev uas nyab xeeb. Tsev neeg kuj tseem yuav raug txiav txim los ntawm tsev hais plaub kom tau txais kev pab cuam CPS los sis tuaj yeem pom zoo kom tau txais cov kev pab cuam uas yeem ntawm siab.

Tsis Muaj Kev Nyab Xeeb - Qhib Rooj Plaub nrog Kev Tso Chaw Nyob Sab Nraum Lub Tsev:

Yog tias tus kws tshaj lij CPS txiav txim siab tias tus me nyuam yuav tsum raug tshem tawm txhawm rau xyuas kom ntseeg tau tias muaj kev nyab xeeb, tus me nyuam raug tshem tawm thiab muab tso rau hauv kev saib xyuas sab nraum lub tsev, raws li lub tsev hais plaub txiav txim los sis daim ntawv cog lus hloov chaw raws kev yeem ntawv siab, uas yuav tsum nrog ib tus neeg uas tus me nyuam twb muaj kev sib raug zoo nrog, xws li ib tug txheeb ze los sis tus phooj ywg ntawm tsev neeg. Child in Need of Protection and Services (Tus Me Nyuam Xav Tau Kev Tiv Thaiv thiab Cov Kev Pab Cuam) (CHIPS) tuaj yeem ua daim ntawv thov foob tau. Cov kev pab cuam uas tau muab rau tus me nyuam thiab tsev neeg feem ntau yog nrog lub hom phiaj ntawm kev sib koom ua ke.

Cov ntaub ntawv txheeb xyuas thoob plaws xeev qhia tau tias nyob rau cov xwm txheej feem ntau, kev koom tes nrog CPS xaus tom qab qhov Initial Assessment (Kev Ntsuam Xyuas Xub Thawj) ua tiav lawm.

Ongoing: How we Help Build Safe, Stable Homes for Children

Información en español

The Ongoing stage is where services are provided based on the initial assessment and conversations with the family. Services may vary based on the needs, strengths and goals of the family. Child welfare professionals will work with the family to establish goals that achieve measurable outcomes and build a safe, stable home for children.



What can I expect in this process?

A child welfare professional will sit down with you to:

- Develop measurable goals to enhance your protective capacity
- Confirm any specific needs and strengths and how those will be addressed
- Identify change strategies to assist you in achieving stability and safe case closure
- Find culturally appropriate services and activities that are easily accessible and meet your needs
- Involve non-custodial or absent parents and relatives as resources for children

Using this information, the child welfare professional will develop the safety/protective plan and share it with you for your review and agreement.

Kuv yuav tiv tauj kuv tus neeg ua hauj lwm thiab lawv tus thawj saib xyuas li cas?

Txhua tus kws tshaj lij CPS muaj nyob hauv lawv cov xov tooj ntawm chaw ua hauj lwm thiab chaw nyob email ntawm chaw ua hauj lwm. Tus kws tshaj lij CPS uas yuav ua hauj lwm nrog koj yuav tsum muab cov ntaub ntawv no thawj zaug uas koj ntsib. Hauv qee lub cheeb tsaam nroog, koj kuj tuaj yeem hu rau CPS tus kws tshaj lij los ntawm kev sau ntawv los sis lwm qhov kev pab cuam xa xov.

CPS cov thawj saib xyuas yuav tsum tau muab kev taw qhia rau lawv cov neeg ua hauj lwm nyob ib ncig ntawm txhua qhov kev txiav txim siab tseem ceeb ntsig txog kev nyab xeeb ntawm tus me nyuam yaus thiab kev nyob mus ib txhis rau txhua tsev neeg. Lawv kuj tuaj yeem yog qhov chaw pab rau cov tsev neeg uas tuaj yeem tau txais txiaj ntsig los ntawm kev sib txuas lus thiab kev piav qhia ntxiv nyob ib puag ncig qhov txheej txheem CPS.

Yuav muaj dab tsi tshwm sim yog tias kuv tsis pom zoo nrog qhov kev txiav txim siab uas ua rau kuv raug tsim txom los sis tsis saib xyuas?

Yog tias koj tau raug lees paub rau kev tsim txom los sis tsis saib xyuas (hauv lwm lo lus, tus kws tshaj lij CPS tau txiav txim siab tias nws yuav muaj tseeb dua li qhov tsis muaj kev tsim txom los sis tsis saib xyuas tshwm sim), koj yuav tau txais tsab ntawv nrog qhov kev txiav txim siab no. Yog tias koj xav sim nrhiav kev tshuaj xyuas los sis rov txiav txim dua ntawm qhov kev txiav txim siab ntawd, koj tuaj yeem ua raws li cov txheej txheem teev tseg hauv koj tsab ntawv txiav txim los sis mus saib nplooj [Child Protective Services Appeal Process](#) (Txheej Txheem Kev Thov Kom Rov Txiam Dua Qhov Kev Pab Cuam Tiv Thaiiv Me Nyuam Yaus).

Kev txiav txim qhov kev thov kom rov txiav txim dua yog lub sij hawm rhiab heev thiab tsis yog ib feem ntawm cov txheej txheem tsis txaus siab. Koj muaj 15 hnub txij li hnub tawm tsab ntawv hais txog qhov kev txiav txim thawj zaug los qhia rau lub koom haum CPS tias koj xav kom lawv tshaj xyuas qhov kev txiav txim. Tom qab lub koom haum CPS ua nws qhov kev txiav txim zaum kawg, koj muaj 10 hnub txij li tsab ntawv ceeb toom ntawm qhov kev txiav txim siab kom rov txiav txim dua mus rau Division of Hearings and Appeals (Chav Lis Hauj Lwm txog Kev Txiat Txim Plaub Ntug thiab Kev Thov Kom Rov Txiat Txim Dua).




