

## Payment Options in Brief

**Use of form:** Use of this form is for child welfare agencies to explain to relative and like-kin caregivers the differences between court-ordered placement options for children in out-of-home care and the assistance that accompanies each option.

**Note:** All children placed in out of home care through a court order are categorically eligible for Foster Care Medicaid (FSTMA), and free and reduced meals programs through school.

Are there any additional requirements to receive the financial assistance?	N/A	Yes <ul style="list-style-type: none"><li>The child welfare agency is required to make a referral to child support</li><li>You are required to apply to become licensed as a foster parent, but if the child welfare agency makes a determination that you cannot be licensed you will continue receiving kinship care payments.</li></ul> <p><b>Note:</b> The child placed in your home may not receive SSI payments to due their own disability and you receive kinship care payments on their behalf at the same time.</p>	Yes <ul style="list-style-type: none"><li>The child welfare agency has discretion on whether a child support referral is made</li><li>You must have homeowner's/renter's liability insurance or have this requirement waived by licensing agency</li><li>You must attest that you will comply with Wisconsin's Foster Care Licensing Administrative Code (on a form that the licensing agency provides you)</li></ul>
