Becoming a regulated child care provider is a great idea! You'll help little ones learn, play, and grow in a safe, nurturing space that Wisconsin children and their families can rely on. It's a rewarding future that's full of opportunities for professional growth. That's especially true for licensed or certified child care providers.

Becoming regulated is the best way to let your community know your program meets Wisconsin's health and safety standards. There are other business benefits too. like:

- Serving families eligible to receive Wisconsin Shares (dcf.wisconsin. gov/wishares) subsidy payments
- Becoming eligible for YoungStar (dcf.wisconsin.gov/youngstar), which provides resources to quality child care programs
- Reaching more families through Wisconsin's Child Care Finder (childcarefinder.wisconsin.gov) online search tool
- Getting referrals from your local Family Resource Center or Child Care Resource and Referral Agency
- Receiving ongoing support from regional licensing specialists or local certification agencies

You've got options!

There are two ways to become a regulated child care provider in Wisconsin: **obtaining certification** or **obtaining a license**. Choose the option that fits your program's size and needs best.



Any provider who cares for up to three unrelated children under the age of 7 can choose to apply for certification. Taking that extra step isn't required by law—and that's the point! Getting certified is a smart and simple way to show your neighbors that you voluntarily meet Wisconsin's health and safety standards. It also connects you with programs and support that can make your child care business stronger. Learn how to get certified on page 3.



In Wisconsin, providers must have a license to care for four or more unrelated children under the age of 7. As a licensed child care provider, you'll get expert advice and ongoing support that will help you meet Wisconsin's health and safety standards. 





Apply for Your License

A local technical consultant will help you submit your initial licensing application.

- Submit the required forms and fees through the online licensing application
- Schedule an initial licensing on-site visit
- Plan your opening day for at least 60 days after your on-site visit, assuming you're awarded a probationary license
