Wisconsin Child Support Program yuav pab tau koj xws li:

- teb koj cov lus nug txog koj rooj plaub thiab kev pab cuam huav Child Support
- nrog koj xyuas tej ntaub ntawv los yog hloov qhov kev them nyiaj yug (qhov hloov ntawd tej zaum qhov nyiaj them tuaj yuav nce los yog txo)
- nrog koj qhov chaw ua hauj lwm xyuas txog kev txiav nyiaj them yug
- muab ntaub ntawv qhia txog kev them nyiaj yug me nyuam nyob rau koj rooj plaub
- muab ntaub ntawv luam qhia txog keeb kwm ntawm koj tus account

Wisconsin Child Support muaj kev pab qhia txog nyiaj rau txhua tus neeg uas raug them los yog tua txais nyiaj yug – nyiaj them yug me nyuam, them yug tsev neeg, ntawv kho mob, thiab nyiaj them yug tus niam los sis tus txiv. Cov kev pab no tsuas yog los xyuas txog kev them nyiaj thiab qhia txog nyiaj txiag hauv tus account.

Leej niam leej txiv yeej mus thov tau kev pab txog nyiaj them yug me nyuam nyob rau ntawm lawv lub koom haum saib xyuas txog phab kev txiav nyiaj them yug me nyuam es tsis tau them nqi tes ua ntaub ntawv. Cov yim neeg uas tau txais W-2, SSI Caretaker Supplement, los yog Kinship Care yeej tau txais cov kev pab cuam no. Muaj tej yim neeg uas tau txais Badger Care Plus yeej tau txais cov kev pab no thiab.

Dhau li ntawm them nyiaj yug me nyuam lawm, puas muaj dab tsi rau kuv ua thiab?

Koj yuav tau qhia rau lub tsev hais plaub thiab koj lub koom haum saib xyuas txog phab kev txiav nyiaj them yug me nyuam paub yog koj tsiv, hloov hauj lwm, los yog nyiaj hli hloov lawm. Lub xeev yuav tsum kom xa daim ntawv ceeb toom no tawm tsis pub dhau 10 hnuv ua hauj lwm tom qab hloov. Cov ntaub ntawv ceeb toom tseem ceeb yog xa tuaj rau hauv tsev. Yuav kom koj tau txais cov ntaub ntawv ceeb toom tseem ceeb koj yuav tau qhia rau koj lub koom haum saib xyuas txog phab kev txiav nyiaj them yug me nyuam thaum koj hloov koj qhov chaw nyob. Lub tsev hais pluab (circuit courts) thiab cov koom hauv saib xyuas txog phab kev txiav nyiaj them yug me nyuam muaj teev nyob hauv phau ntawv teev xov tooj nyob hauv “County Government” los yog pab pawg neeg lub npe. Txiav Nyiaj (Income withholding)

Koj qhov chaw ua hauj lwm yuav tau txais daim ntawv ceeb toom kom txiav nyiaj them yug. Koj qhov chaw ua hauj lwm txiav qhov nyiaj them yug tawm ntawm koj daim tshv es muab xa mus rau hauv Wisconsin Support Collections Trust Fund kom lawv mam them tuaj. Tej zaum cov chaw ua hauj lwm yuav tsub ib tug nqi tes \$3.00 rau thaum txiav nyiaj ib zaug los them rau nqi ua ntaub ntawv. Tej zaum kuj yuav txiav nyiaj them yug me nyuam tawm ntawm niam txiv cov nyiaj poob hauj lwm, nyiaj raug mob tom hauj lwm, nyiaj laus, thiab nyiaj Social Security Disability Income (SSDI).

Yog koj poob hauj lwm los yog raug hu mus ua tub rog, thov hu rau koj lub koom haum saib xyuas txog phab kev txiav nyiaj them yug me nyuam. Tej zaum lawv yuav pab tau.

Yog koj tshuav nqi them tsis tau tas, qhov nyiaj pib txiav tawm ntawm koj daim tshv yuav ntau dua qhov lub tsev hais plaub tau txiav txim. Tej zaum tus nqi teev nyob rau hauv koj daim ntawv ceeb toom yuav nce mus txog li 50% ntawm qhov koj them ziang no. Piv txwv tias, qhov tsev hais plaub txiav txim rau koj them yog \$250/ hli rau ziang no. Koj daim ntawv ceeb toom yuav ntxiv \$125 (50% ntawm \$250). Tus nqi txiav tag nrho yuav yog li \$375 (\$250 rau qhov them ziang no, thiab \$125 them rau qhov poob qab lawm). Txoj cai Consumer Credit Protection Act yuav muab los siv rau qhov no thiab. Saib lo lus nug tom ntej no txog cov kev txwv no ntxiv.

Kuv qhov chaw ua hauj lwm yuav txiav tau nyiaj npaum li cas tawm ntawm kuv daim tshv mus them yug me nyuam?

Tseem fwm txoj cai **Consumer Credit Protection Act** (saib kom paub ntau ntxiv txog cov kev txwv no) txwv tsuas pub txiav nyiaj kom txog ib tug nqi xwb. Tsab ntawv ceeb toom txog cov nyiaj muab tuav cia uas koj tus tswv hauj lwm tau txais teev cov nyiaj muab tuav cia tsis pub tshaj uas pom hauv qab no. Yog koj qhov chaw ua hauj lwm txiav tsis tas tus nqi koj raug them, **koj yuav tau them qhov txiav tsis tas ntawd**. Koj yeej hais tau koj qhov chaw ua hauj lwm kom txiav tus nqi them yug kom tas li yuav tau them, txawm tias yuav ntau tshaj qhov lawv txwv. Txoj cai Consumer Credit Protection Act txwv li no:

- 50% ntawm koj lub nyiaj hli khwv tau tom qab txiav se yog koj muaj tsev neeg thib ob
- 55% ntawm koj lub nyiaj hli khwv tau tom qab txiav se yog koj muaj tsev neeg thib ob thiab them nyiaj yug uas poob qab tshaj 12 lub lis piam lawm
- 60% ntawm koj lub nyiaj hli khwv tau tom qab txiav se yog koj tsis muaj tsev neeg thib ob
- 65% ntawm koj lub nyiaj hli khwv tau tom qab txiav se yog koj tsis muaj tsev neeg thib ob thiab them nyiaj yug uas poob qab tsaj 12 lub lis piam lawm

Qhov nyiaj nqa los tsev yog qhov nyiaj uas khwv tau tom qab txiav se tawm mus rau tseem fwm, lub xeev, thiab hauv zos thiab se rau Social Security.

Kuv ua ob txoj hauj lwm. Ob qho chaw ua hauj lwm puas yuav txiav nyiaj yug me nyuam tib si?

Tej zaum lawv yuav txiav tej zaum law yuav tsis txiav. Tag nrho tus nqi txiav rau ib lub hlis twg yuav tsum yog tib tug nqi uas teev nyob hauv daim ntawv ceeb toom mus rau ib qhov chaw los yog ob qho tib si mus them yug. Koj lub koom haum saib xyuas kev txiav nyiaj them yug me nyuam yuav tsum muab ib daim qauv ntawm tsab ntawm ceeb toom txog qhov muab cov nyiaj tuav cia, uas qhia rau koj paub seb qhov nyiaj muab tuav cia los ntawm ib tug tswv hauj lwm yog ntau npaum cas. Yog koj tsis tau txais ib tsab ntawv ceeb toom txog cov nyiaj muab tuav cia, koj nug tau koj lub koom haum saib xyuas kev txiav nyiaj them yug me nyuam kom luam ib daim rau koj. Tseem siv tseem fwm txoj cai Consumer Credit Protection Act rau qhov no. Saib lo lus nug saum tom no txog cov kev txwv no ntxiv.

Kuv qhov chaw ua hauj lwm tsis zoo siab txog kev txiav nyiaj vim muaj ntaub ntawv ntau heev. Kuv ntshai tsam kuv poob hauj lwm.

Raws txoj cai, koj qhov chaw ua hauj lwm yuav nrho tsis tau koj tawm hauj lwm vim qhov txiav nyiaj no. Yog koj qhia tau hais tias kev txiav nyiaj no ua tau rau kom muaj teeb meem rau koj, koj yuav hais tau kom lub tsev hais plaub nrhiav lwm txoj kev rau koj them. “Irreparable harm” yog qhov kev phem ua kom tsis zoo rau koj uas yuav kho tsis tau li lawm. Qhov koj thov yuav tsum muab hais rau kws txiav txim plaub ntug tsis pub dhau 10 hnuv suav txij hnuv muab tsab ntawv ceeb toom txog qhov muab cov nyiaj tuav cia xa tuaj rau koj.

Muaj ntau yam ntxiv txog txiav nyiaj

Yuav ua li cas yog txiav nyiaj yuam kev? Yuav ua li cas yog kuv qhov chaw ua hauj lwm txiav nyiaj ntau tshaj qhov teev hauv daim ntawv ceeb toom txiav nyiaj los yog tsis xa nyiaj mus rau lub Trust Fund?

Yog qhov nyiaj txiav tawm tsis yog raws li qhov teev hauv koj daim ntawv ceeb toom, koj yuav tsum qhia rau koj qhov chaw ua hauj lwm. Koj muaj feem xyuam xyuas txog koj qhov nyiaj them yug me nyuam uas tsev hais plaub txiav txim, txawm tias koj qhov chaw ua hauj lwm tsis txiav nyiaj tawm, txiav nyiaj tsis yog tus nqi, los yog tsis xa qhov nyiaj mus rau hauv lub Trust Fund. Cov chaw ua hauj lwm yuav tsum xa cov nyiaj txiav them yug mus rau lub Trust Fund tsis pub dhau tsib hnub txij hnub txiav nyiaj. Qhov chaw ua hauj lwm uas txiav nyiaj them yug tab sis tsis xa qhov nyiaj mus rau hauv lub Trust Fund yog yuam txoj cai lawm. Hu rau koj lub koom haum saib xyuas txog phab kev txiav nyiaj them yug me nyuam yog koj qhov chaw ua hauj lwm tsis xa qhov nyiaj txiav them yug mus rau lub Trust Fund.

Yog ua cas kuv thiaj sau tsis tau tshev mus them xwb?

Wisconsin txoj cai hais kom txiav nyiaj. Raws li muaj, tsuas yog cov niam/txiv uas ua hauj lwm rau nws tus kheej thiaj tsis raug txiav nyiaj xwb. Tej zaum cov niam txiv no yuav tau xyuas kom muaj ib txoj kev tuaj rho nyiaj tawm ncaj qha ntawm lawv lub txhab tso nyiaj (bank).

Puas muab qhov nyiaj txiav ntawd ua ib tug nqi tes rau Receipt and Disbursement (R&D)?

Muab, tiam sis tsuas yog thaum twg tus niam/txiv ntawd tsis them tus nqi tes kom txwm xyoo los yog tseem tshuav nqi them tsis tau tas rau R&D ntau xyoo dhau los. Yog tseem them tsis tau tas, peb yuav hais kom koj qhov chaw ua hauj lwm txiav nyiaj them tus nqi tes uas dhau lawm rau R&D peb zaug huav ib xyoo (caij nplooj ntoos hlav, ntuj sov, thiab caij nplooj ntoos poob). Yog koj ua hauj lwm rau ntau tshaj ib qho chaw, tsuas yog ib qho chaw ua hauj lwm thiaj raug txiav qhov nyiaj nqi tes rau R&D xwb. Yog xav paub ntxiv txog qhov nqi them no, mus saib ntawm dcf.wisconsin.gov/bcs.

Daim ntawv qhia them nyiaj txhua hli thiab cov coupons

Peb yuav xa daim ntawv qhia them nyiaj txhua hli thiab cov coupons tuaj rau koj yog koj muaj li nram qab no:

1. Koj tsis raug txiav nyiaj
2. Koj poob qab rau kev them nyiaj
3. Koj nyuam qhuav xa nyiaj nrog daim coupon mus rau lub Trust Fund
4. Koj hais kom koj lub koom haum saib xyuas txog phab kev txiav nyiaj them yug me nyuam xa daim ntawv qhia them nyiaj thiab cov coupons tuaj rau koj txhua hli

Yog koj zwm npe rau hauv Child Support Online Services lub website ntawm dcf.wisconsin.gov/bcs (lus As Kiv), koj yuav

- Saib tau qhov nyiaj them thiab seb tshuav npaum li cas
- Saib thiab luam cov coupons thiab keeb kwm ntawm cov nyiaj koj them

Muaj ntau yam ntxiv txog daim ntawv qhia them nyiaj txhua hli thiab cov coupons

Ntawv Ceeb Toom txog R&D Tus Nqi Tes thiab cov Coupons

Txhua lub Ib Hlis Ntuj, peb yuav xa daim ntawv ceeb toom txog koj cov nqi tes hauv R&D nrog ib daim coupon rau R&D qhov nqi tes. Yog koj tseem tshuav nqi tes rau R&D thiab koj tsis siv kev txiav nyiaj, koj yuav tau txais ib daim ntawv ceeb toom txog R&D nrog rau ib daim coupon rau thaum lub Plaub Hlis, Xya Hli, thiab Kaum Hli.

Kuv qhov chaw ua hauj lwm siv puas tau kuv cov coupons?

Tsis tau. Thov tsis txhob muab cov coupons no rau koj qhov chaw ua hauj lwm siv. Cov chaw ua hauj lwm yuav tau lawv ib cov ntawv rau kev txiav nyiaj them yug thiab rau cov nqi tes hauv R&D.

Kuv yuav siv daim coupon twg mus them rau yam twg?

- Siv daim coupon kom yog rau qhov koj them. Ib daim coupon twg yuav qhia tau rau lub Trust Fund kom muab koj qhov nyiaj mus them rau kev yug los yog them rau cov nqi tes hauv R&D. Yog koj siv daim coupon tsis yog, koj qhov nyiaj them yuav muab them rau qhov tsis yog.
 - Siv daim **Payment Coupon** mus them rau kev them nyiaj yug, qhov poob qab them lawm, thiab tus paj.
 - Siv daim **Coupon rau R&D** mus them rau koj qhov R&D nqi tes.
- **Tsis txhob siv cov coupons no** mus ua ib qhov kev them li tau pom zoo nrog koj lub koom haum saib xyuas txog phab kev txiav nyiaj them yug me nyuam kom tsis txhob muaj teeb meem nrog lub koom haum txog rau daim Lien Docket. Txog ntawm tej yam nqi li no, hu mus rau koj lub koom haum saib xyuas txog phab kev txiav nyiaj them yug me nyuam kom tau lwm daim ntawv.

Kuv tseem them cov nyiaj yug rau ob tse neeg uas kuv poob qab lawm. Muaj tej yam tshwm sim, es tej zaum ib tse neeg xav tau nyiaj ntau dua qhov kuv them txhua lub hlis. Kuv yuav ua li cas es qhov nyiaj tshaj ntawd thiaj mus nca qha rau tsev neeg ntawd?

Yog koj xav them me ntsis ntxiv mus pab ib tse neeg, siv koj daim Payment Coupon es “teev” qhov nyiaj them ntawv xa ncaj qha mus rau qhov specific court case ntawd. Sau tsev neeg ntawd tus case number uas nyob ntawm kab sau hais tias “Designated Court Case?”, **thiab** kos rau lub box nyob rau ntawm sab xis ntawm txoj kab. Saib daim coupon phab 5.

Kuv yuav tsum them tus nqi yug \$75 txhua lub lis piam thaum kuv lav nyiaj, es kuv yeej them. Yog li cas kuv daim ntauwv qhia txhua hli hais tias kuv tseem tshuav nqi?

Thaum tsev hais plaub txiav txim rau tus niam/txiv them nyiaj yug txhua lub lis piam los yog ob lub lis piam twg, hnuv them (“charge day”) qhov nyiaj ntawd yog muab ntaus rau hauv KIDS qhov computer system. Yog koj qhov nyiaj txiav them xa tawm rau hnuv koj lav nyiaj, tab sis KIDS hnuv xam rau kom koj them yog hnuv txawv hauv lub lis piam ntawd, koj tus account yuav tsis haum mus li ob peb lub hlis.

Nyob rau cov hli uas cov hnuv them ntau dua cov hnuv lav nyiaj, koj daim ntauwv qhia yuav pom tias tsis muaj nyiaj txaus. Qhov nyiaj tsis txaus rau cov hli no hu ua “sij hawm poob qab (timing arrears).” Tsis muaj paj yuav tsub rau cov sij hawm poob qab no, thiab yuav tsis ua dab tsi.
