Good Afternoon,

The moratorium on utility disconnections, a year-long order preventing utilities from disconnecting services due to nonpayment, expires on Thursday, April 15. The expiration of the moratorium could leave over 93,000 Wisconsin homes at risk of utility disconnection. Many utility providers have offered some flexibility in payment plans of past-due amounts to their customers due to the COVID-19 pandemic. Individuals who are behind on utility payments should first contact their service provider to discuss repayment agreements. We encourage you to inform W-2 participants who may be behind on, or struggling to pay, their utilities that there are energy assistance resources available to them:

The **Wisconsin Home Energy Assistance Program** (WHEAP) is a program designed to assist low-income families in heating and electric costs. For WHEAP application and eligibility information call 1-866-432-8947 or visit <u>benefits.gov/benefit/1397</u>, or apply online here: <u>energybenefit.wi.gov</u>.

The **Energy Assistance Program** is available to Milwaukee County residents to assist in electric and heating bills. This program pays a portion of energy costs determined by household size, income, and energy costs.
