Hello.

Operations memo 20-09 [COVID-19 Expanded Unemployment Insurance Benefits](#) is being amended to include the information below and will be published in the next few days.

Starting May 21, 2020, PUA payments will display in CWW. During any program's Intake driver flow, the lump sum PUA payment will autopopulate the Unearned Income page with the OTTF code and the begin and end month that the lump sum was received.

For ongoing cases, the FEP must create an Unearned Income page and use the OTAF income type for lump sum PUA payments. OTAF ensures the lump sum will count only for W-2. For ongoing weekly payments, the FEP must use the OTTF code since both W-2 and Wisconsin Shares count ongoing PUA payments.

PUA payments will appear on the UIB Details page with the P indicator in the Type column and BENEFIT PAYMENT, NEXT CARD SENT in the Remarks column, which is the same display as regular unemployment payments.
