As summer programs are underway and the school year approaches, it is critical to ensure all adolescents 12 years and older get vaccinated against COVID-19. As a trusted organization and voice in your community, the Wisconsin Department of Health Services (DHS) needs your help sharing messages and materials with the families that you serve. DHS has created the toolkit, below, for you to facilitate outreach with the youth you serve, their families, and your community about vaccination for people 12 years of age and older.
