## **PURPOSE**

The purpose of this memo is to explain the impact of Phase II of the FoodShare Employment and Training (FSET) changes on the CARES Work Programs (WP) subsystem. There are no Wisconsin Works (W-2) policy changes associated with this memo.

#### **BACKGROUND**

Due to a provision in Wisconsin's 2013-15 biennial budget the Department of Health Services (DHS) anticipated that participation in FSET would increase significantly. To support the potential increase in the FSET caseload, DHS decided to make structural changes to the FSET

program, including moving the FSET functionality out of the CARES WP subsystem and into CARES Worker Web (CWW). DHS decided to use a phased-in approach.

Effective July 1, 2014, under Phase I, DHS implementation occurred in the Southeast FSET Region 1 (Kenosha, Racine, and Walworth Counties). Effective March 21, 2015, under Phase II, DHS is expanding these changes statewide.

This memo describes the impacts of the Phase II statewide implementation on the WP subsystem.

There are no policy changes associated with this memo.

- FSET agencies will disenroll existing FSET participants from the CARES WP subsystem between March 23 and March 31, 2015. (See DHS Operations Memo 14-56.) FoodShare workers and FEPs are no longer required to coordinate CARES Work Programs office assignment for co-enrolled individuals.
- 3. The AEO1 Work Programs Referral letter will be obsolete. DHS will no longer use this letter for FSET referrals, and W-2 agencies have no need to continue using the letter.
