PURPOSE

This Operations Memo describes CARES Work Programs (WP) and CARES Worker Web (CWW) changes that will support policies associated with the Wisconsin Works (W-2) Trial Employment Match Program (TEMP) time limits and treatment of subsidized employment and stipend payments.

BACKGROUND

BWF Operations Memo <u>16-03</u> announced the implementation of the W-2 TEMP and Expanded Noncustodial (NCP) Services pilot. The Memo provided policy regarding participation in the TEMP Custodial Parent (TMP), TEMP Noncustodial Parent (TNP), and Stipends Noncustodial Parent (TSP) placements and explained the CARES WP modifications to support the pilot.

This Memo addresses the following:

- Modifications to CARES WP screen AIWC to add the TMP and TNP placement types and a TEMP 24-month cumulative clock.
- Enhancements to the CWW W-2 Clocks Information page to read the TMP and TNP placement types and display the TEMP 24-month cumulative clock.
- Modifications to the CWW Employment page to display new labels for the "T" employment type menu and subsidy field.
- Policy reminders on treatment of subsidized employment income and stipend payments.

CARES WORK PROGRAMS

Effective April 1, 2016, CARES screen AIWC will include the new TMP and TNP placement types and TEMP 24-month cumulative clock.



There are no changes to the page functionality for computing financial eligibility for assistance programs.

New label: "T - SUBSIDIZED EMPLOYMENT"



The new employment type menu and subsidy field labels will display for historical records created prior to April 1, 2016.

When an individual reports a change in subsidized employment, the worker must review the **Subsidized Employment Subsidy** field and make changes if needed.

POLICY REMINDERS

SUBSIDIZED EMPLOYMENT INCOME

In keeping with current policies, subsidized wages earned as part of TEMP are disregarded for W-2 and Wisconsin Shares Child Care Assistance but are counted as income for FoodShare, BadgerCare Plus, Medicaid, and Caretaker Supplement. As noted above, the Employment page changes do not change the policies on how these wages are counted. Workers must continue to use the "T" employment type for subsidized income from TEMP and the Transform

Milwaukee Jobs (TMJ) program (see <u>DHS Operations Memo 14-44, "Treatment of Transform Milwaukee Jobs Income"</u>).

Workers are reminded that individuals placed in subsidized employment under TEMP or TMJ are ineligible for Transitional FoodShare.

STIPEND PAYMENTS

Stipend payments are disregarded in determining financial eligibility for W-2, Wisconsin Shares Child Care Assistance, FoodShare, BadgerCare Plus, Medicaid, and Caretaker Supplement. Workers must enter stipend payments in CWW using the "OTTF – OTHER – TANF ONLY" unearned income type.

ACTION REQUIRED

W-2 agencies and child care eligibility and authorization workers must discuss these CARES changes with staff and update any relevant local agency procedures.
