PURPOSE

The purpose of this Operations Memo is to announce updates to the CWW Time Limit Information page.

BACKGROUND

As described in [Operations Memo 17-15: Modernization of CARES Mainframe Time Limit Screens](#), in August 2017, the Bureau of Working Families moved mainframe time limit screens to the web-based Wisconsin Work Programs (WWP) application. This move was part of the Department of Children and Families' goal to modernize the CARES Work Program Subsystem from a mainframe system to a web-based application.

The WWP application displays information using the SQL Server database. To display this information in CWW, the data must be modified to accommodate CWW's DB2 database. This modification process can result in display errors. By populating CWW directly from WWP and the SQL Server database, these CWW display errors will be eliminated.
